Victoria Kniewel announced the names of teachers and staff eligible for tenure at the end of the current school year. Victoria talked about the tenure process and said that the tenure law for teachers in New York State has been in existence since 1917 and that the legal intent for tenure was to protect the integrity of teachers. She explained that there are some recent changes in the tenure laws. Teachers and administrators hired on or after July 1, 2015 will be subject to a four-year probationary period.

Victoria concluded by saying that she welcomes feedback from students and parents.

David M. C. Stern said that announcing the names of the teachers eligible for tenure has been an Edgemont tradition in an effort to enhance communication and solicit feedback from members of the community.

There were some community comments/questions regarding the tenure law. Victoria Kniewel said that everyone in this group is under the old tenure law.

Edgemont District Technology Plan 2015-2018

Michael Curtin

Victoria Kniewel invited Mike Curtin to talk about the District Technology Plan. Using PowerPoint, Mike explained that the State education regulations require that districts have a technology plan on file to receive aid targeted through the Smart Schools Bond Act. For Edgemont, the aid reflects an additional \$302,000. Mike said that the plan was written using the data from the 2014 Clarity technology assessment and input from the technology action planning team.

Mike concluded with a review of the three broad goals:

- Increasing access to technology with eventual one-to-one computing in grades 5-8.;
- Improving technical and instructional support, including professional development;
- Revising curriculum and instruction

A question and answer conversation ensued among board members. There were some community questions and comments regarding professional development, security, and the importance of teaching students how technology works.

David M. C. Stern thanked Mike for an organized and informative presentation.
