VIII. Section One Report

(D) Frequent game change requests and inability to cover contests

Discussion:

- AD's should be working with their Spring coaches to make all initial changes to their schedule.
- Todd Santabarbara shared the increase in the number of day of game changes impacting game coverage.
- Members of the Council discussed the need for a cultural shift in game changes. Council members shared that other sections throughout NYSPHSAA treat game changes very differently than Section One. Other sections are currently more restrictive than Section One.

(I) Status of Section 1 Basketball Championship venue

Discussion:

- The Executive Committee is scheduled to consider the approval of the Westchester County Center contract on Monday January 30th, 2023
- A site visit of the County Center is scheduled for later this week. Todd has invited the Section One Officers to join him.
- A timely decision is necessary to fairly balance the relationship with the County and the member schools who are part of our approved contingency plan.

IX. NYSPHSAA Report: Dr. Robert Zayas, NYSPHSAA Executive Director

Dr. Robert Zayas reported the following:

- The NYSPHSAA office appreciates The Athletic Council of Section One scheduling their meetings just before the Central/Executive Committee meeting. The Executive Director shared his perspective that it was incredibly helpful in the decision-making process ensuring that all member schools have the ability to review agenda items and weigh-in on proposals being discussed at the state level.
- Due to the conflict with the History Regents, the Boys Tennis Individual Championship is being moved from June 2^{nd} to June 4^{th}
- After going more than a decade without a change in membership dues the NYSPHSAA office is proposing an increase to help address their anticipated deficit for the upcoming school year. The Budget and Audit Committee has endorsed an increase from the current cost breakdown of \$810 and \$0.86 / students over 300 to \$1000 and a \$1.00 for every student over 300.
- NYSPHSAA Sub-Committee meetings February 6th, 2023
 - o **Transfer & Eligibility Committee** Todd Santabarbara will attend as the Section One rep. The meeting will include discussion around extended eligibility.
 - **DEI Committee** Kim Saxton (Blind Brook) is the Section One sub-committee rep. Our Section would like to reinforce its interest in utilizing the NYSPHSAA Handbook language related to fighting to be considered for incidence of bias.
 - Combining of Teams Committee Austin Goldberg (Peekskill) and Jesse Merchant is the Section One sub-committee rep. Dr. Zayas shared concerns from the membership regarding how many schools are merging. There was a brief discussion about the utilization of the percentage of BEDS within the Combining of Teams formula.
 - o Fall 2024 has a start date of August 24th, 2024 while all other Fall sports begin August 26th, 2024. This is the latest start date in quite some time.
