(I) Amendments to the Section One Boys & Girls Golf Championships – approved 3.20.23

Discussion:

(I) Consider approval of mergers for the 2022-23 school year – approved 3.20.23

Discussion:

The Executive Committee approved all Merger / Combining of Teams applications on March 20th, 2023. The only merger that did not have complete review of the conferences was the Irvington Flag Football merger.

XI. Self-Reports:

• Riverside Boys Basketball – use of an ineligible player Rob Webb, Yonkers Public Schools & James Hoffman, Riverside Athletic Director

Riverside used an ineligible player on their Varsity Boys Basketball team. The Athletic Director reported that one of their student-athletes went through the transfer process and recorded an inaccurate date for his entry into 9th grade. Upon identifying the error in the transfer paperwork, the athletic administrators removed him from the program and spoke with the parents/guardians of the athlete. As a result of the player participating in contests, the prescribed NYSPHSAA penalty was applied resulting in a forfeiture of the applicable games. The Athletic Council determined that no further sanction was necessary.

XIII. Senior All-Star Applications:

(I/D) NYSPHSAA / Section general liability coverage vs. Student / Accident coverage

Discussion:

Todd Santabarbara shared that the potential host school for the Boys Lacrosse Senior All-Star game, and its athletic director, will not sign the application until appropriate insurance coverage is provided.

Loomis & LaPann provided clarification: if approved by the Section, the NYSPHSAA / Section general liability coverage would apply to senior all-star contests. However, student accident coverage is not provided. Therefore, the Athletic Council would need to:

- a. require the host or Coaches Association to purchase one-time student accidental coverage as a pre-requisite for approval, or
- b. develop a way to verify that each participating student would be covered under their own districts' student accident coverage.

(I/D) Framework / procedures for Senior All-Star approval

Discussion:

Discussion occurred around the need to require coaches' associations to purchase student accident insurance as a pre-requisite to Athletic Council approval of senior all-star games.

(D) Consideration of the BOYS LACROSSE Senior All-Star game (June 3rd at Irvington HS)

<u>Discussion</u>: The Athletic Council established the next steps and list of options for the Boys Lacrosse all-star event request:

- a. Coaches Association must find a host district willing to sign off, or
- *b. Inquire if the Coaches Association is willing/interested in purchasing the recommended insurance coverage for the event, or*
- c. The Association can choose to run the event as a non-section affiliated event while having the athletes participate unattached from their home school.
