

## INSTRUCTIONS FOR THE AMERICAN LEGION JOHN H. SECOR POST 329 AND THOMAS A. DEXTER SCHOLARSHIPS

- 1. The applicant must file the following with the Scholarship Committee: A complete application. It should be neat, and contain all required information as outlined in the "Criteria Used To Determine Winner."
- 2. Applicant(s) for a Thomas A. Dexter Scholarship must be a bona fide senior at Pearl River High School. Applicant(s) for a John H. Secor Post 329 Scholarship must be the son/daughter, grandson/granddaughter of a current member of American Legion Post #329.
- 3. Applicant(s) must have been accepted to an accredited College/University. List the name of the Institution where requested on the application.
- 4. The scholarships will be awarded to students only upon acceptance to the school of their choice.
- The recipients of the awards must refund any money returned by the institution for 5. non-matriculation.
- 6. The Committee reserves the right to verify any application.
