# NAACP YOUTH & COLLEGE DIVISION STUDENT CODE OF CONDUCT

- 1. Members shall be prompt and prepared for all scheduled activities

- 3. Members shall not deface public property nor remove hotel property such as keys or towels from the premises. The individual will pay for any property damages or losses incurred.
- 4. Keep chaperones advised at all times of activities and whereabouts.
- 5. No UNDER-AGE members is to leave the premises without a chaperone. Do not take a taxi or other public transportation to restaurants or areas of sightseeing without chaperone approval.
