Dr. Robert Zayas reported the following:

- The NYSPHSAA Diversity, Equity & Inclusion Committee is actively seeking representation from each of the 11 sections.
- The NYSPHSAA Executive Committee is seeking representation from each of the 11 sections to serve on a sub-committee to examine the placement of charter schools within Section VI. This sub-committee would be charged with providing a recommendation to the Executive Committee regarding these school's league placement.
- Ball Adoption
 - 1. The NYSPHSAA office is seeking permission from all 11 sections to complete an RFP on their behalf.
 - 2. Working toward a May 2023 Announcement
 - 3. Implementation in Fall 2024
 - 4. Feedback has been collected from Section Executive Directors and Sport Coordinators.
- The US History Regents Exam recently changed it's dates of administration which now conflict with the first day of the Individual Boys Tennis Championships.
- The NYSPHSAA Budget Audit Committee is anticipating a roughly \$200,000 deficit for the upcoming year. In response, the committee is recommending an increase in membership dues over the next three fiscal years:

The Championship Committee looked to provide clarification around the language within the proposal. The following feedback was provided:

- 2. Will not be following "Winners of each bracket play each other" instead

Will be following – Top 2 teams in each bracket play each other, 1 bracket #1 vs 1A bracket #2, 1A bracket #1 vs 1 Bracket #2 (see proposal)

- 3. Amended language: If an odd number of teams qualify (24 or more), the side of the bracket with the #1 overall (seeding) index, of all qualifying teams, will be the bracket with the fewer number of teams.
- (I/D) Feedback on the proposed winter 2022-23 tournament calendar and championship venues

Discussion:

The Championship Committee discussed utilizing the seeding meeting as a deadline for a decision regarding the use of a non-school based venue. The Athletic Council discussed the use of the January

30th Executive Committee meeting as a deadline instead because of concerns around the ability to host such a complex event on short notice. Final approval will remain with the Executive Committee.
