Cluster home instruction groups if on same grade level so same teacher is working with one grade level. Give information on what in school instruction looks like and what home instruction looks like. District wide info guidance so parents can make informed decisions. Maybe do over zoom for multiple students. Need to see how many vulnerable students there are before making decisions. Must explain this is NOT remote-robo calls, email and on website. Principal coffee/tea if needed - ANONYMOUS
- 8. Older students can still log on and compete work..7-12. Will they offer streaming/remote? HS stream in live. Teacher on assignments (sub) report to building for the students who are on quarantine and that sub will support those students. Vary depending on case and depends on CDC quidelines. Group 4

- 1) Let parents choose. Recommend mask wearing for those who are not vaccinated.
- 2) If masked, students will get mask breaks during lunch and recess. Students can ask for mask breaks as needed. Scheduling mask breaks may be helpful. Elementary teachers can post a schedule with mask breaks. Ideally mask breaks would be taken outside.
- 3) If masks are mandated, we would need to follow DOH guidance.
- 4) We will need to have more data and information regarding students who are immuno-compromised. This needs to be looked at on a case-by-case basis based on medical need.
- 5) Committee was unsure. 504 learning plans seem to make sense under these circumstances. This would be a good opportunity to develop criteria for individualized plans.
- 6) The district should send out a letter specifying the criteria or a form for a medical professional to complete for immunocompromised students.
- 7) A district level communication to all parents to emphasize the importance of in-person learning and specifying that a remote option is not available but at-home instruction for 1 2 hours per week will be availed to those with medical needs.
- 8) One option is that students who are quarantined may be granted home instruction. More discussion about making remote learning available when students are quarantined should be discussed. Remote learning should not be expected on a regular basis, but should be considered for mandated COVID quarantines.

- (Self-selecting day-by-day remote learning should not be an option).
- 9) Remote learning should be availed if the whole class is quarantined.

- 11) Do we have to use a screener? Is it working as a preventive measure?
- 12) The screeners did not seem to working effectively. Can we consider removing the screener?
- 13) Daily cleaning and disinfection. After quarantines, additional cleaning/disinfection as well. Continue the same cleaning protocols as last year.
- 14) Dividers should be optional.
- 15) Follow DOH guidelines for high transmission communities. Be prepared to shift to remote learning (make sure all students have computers and internet access should the need for remote learning arise).
- 16) In the best interest of students' academic success, we want to avoid hybrid learning.
- 17) We need to be clear and consistent about the health protocols we adopt at a school district. Classroom teachers are provided the supplies needed for hygiene protocols.

- Masks should be mandated for 12 and under, there is a substantial uptick in this age group. If we are in high transmission, we should mandate masks.
