From the Superintendent

On May 21st, the residents of the Pearl River School District will be asked to consider a proposed school budget that has been developed to align with the District's Mission, that all students can and will learn, as well as the District's core values: fiscal responsibility, improving student achievement, and improving the public's perception.

Anticipating a difficult budget year ahead, the District Administration entered the budget development process aided by guiding principles to support our decision making process. We have worked at identifying cost saving measures, and keeping losses and reductions to a minimum, while preserving and advancing our academic programs, where possible.

Through innovation and investment in essential elements for long-term success, such as professional development, and curricular resources in literacy, mathematics, technology, and science, the budget supports student learning opportunities consistent with the 21st Century skills that are critically important for our current students and future graduating classes.

The Capital Projects are a continuing visible feature of the District's progress and we will see that work enter its second phase in the months ahead. In addition to the work addressed by the Capital Projects, the 2019-20 budget also includes support for the District's physical infrastructure by providing funding for the needed replacement of equipment, resurfacing of paved areas, painting, and smaller scale projects at each school that are not included in the Capital Projects work.

As always, we are grateful for the support of the Pearl River School District Community and the privilege of serving the educational needs of its children.

I urge all Pearl River residents to exercise their right to vote on Tuesday, May 21, 2019. Any district resident who is eligible to vote but is unable to get to the polls on that day can contact Mary Flanagan, District Clerk, at 620-3924 for an absentee ballot. Thank you for your support.

Budget Highlights

2019-20 Proposed Budget: \$69,240,850 2019-20 Proposed Budget to Budget increase: 1.71% 2019-20 Tax Levy Increase: 1.52%

The Proposed Tax Levy increase of 1.52% is Equal to the NYS Property Tax Cap Allowed. Estimated Tax Rate Increase for Homeowners: approximately 0.6% Estimated Tax Rate Increase for Non-Homestead: approximately 3.4%

<u>Important Note</u>: Tax rates are estimates only and may change due to adjustments in total assessments and base proportion allocations between homestead and non-homestead properties which are not finalized until August.

The annual budget vote for the fiscal year 2019-20 by the qualified voters of the Pearl River Union Free School District, Rockland County, New York, will be held at Pearl River High School in said district on Tuesday, May 21, 2019 between the hours of 7:00 a.m. and 9:00 p.m., prevailing time in the Pearl River High School, at which time the polls will be opened to vote by voting ballot or machine.

1. The basic school tax relief (STAR) exemption is authorized by section 425 of the Real Property Tax Law.

Revenue Highlights:

- Tax Levy increase of \$841K (1.52%) is within the allowable tax levy limit;
- State Aid increase of \$414K (3.9%);
- PILOT revenue increase of \$270K;
- Planned use of \$86K in Fund Balance to balance the budget.

Expense Management:

- Budget to budget increase of \$1,162K (1.71%);
- Increase over Projected 2018-19 Projected spending of only \$403K (0.59%).

What Will it All Cost?

- For a home assessed at \$200,000 the projected school tax increase is \$24 per year;
- Final Tax Rate information available in August.

Board of Education Elections

There are two seats up for election, those currently held by Robert Davis and Christine Reddy. Both incumbents are seeking re-election and are running unopposed. The term of office is July 1, 2019 through June 30, 2022.
