Discussion:

- As one of the governing bodies, Athletic Council needs to be part of the solution to the challenges the section is experiencing around the shortage of officials.
- NYSPHSAA launched a school based official program, however, it is unclear how many, if any schools have taken advantage of it in our region.
- The Section office has made changes to streamline and expedite the process for new officials.

- Conversations are occurring at the state level with the state OCF to streamline the certification process for sub varsity, especially modified officials.

• Sleepy Hollow Varsity Football – *joint practice violation*

Sleepy Hollow violated the joint practice standard and participated in an 11 v. 11 scrimmage-like situation prior to accruing the appropriate number of practices. The Athletic Director reported that the school district suspended the Head Coach for the first game of the season. Athletic Council determined no further sanction was necessary.

• Valhalla Varsity Football – *joint practice violation*

Valhalla violated the joint practice standard and participated in an 11 v. 11 scrimmage-like situation prior to accruing the appropriate number of practices. The Athletic Director reported that the school district suspended the Head Coach for the first game of the season. Athletic Council determined no further sanction was necessary.

• North Salem JV Girls Soccer – use of an ineligible player

North Salem utilized an ineligible player on their JV Girls Soccer team. The Athletic Director reported that the JV Girls Soccer team only has 8 players. To maintain both a varsity and JV level program, the Athletic Director had been meeting regularly with the coaching staff to devise a plan that included the rotation of players among the two teams without exceeding the maximum number of contests. Furthermore, the Athletic Director reported that utilizing the same players on the same day was never discussed. As a result of one player playing in two contests on the same day, the prescribed NYSPHSAA penalty was applied resulting in a forfeiture of the JV girls soccer game.
