If the guest is employed or in the military, his/her immediate supervisor/superior must give his/her recommendation. If the student is attending college and unemployed, no administrator signature is required. If the guest is a graduate or former student of Delone Catholic High School, a check will be done on his/her discipline record during the last year of enrollment at the school.
