• Vaccination Requirement at Armory (NYCDOH)

Discussion:

- A list of sites that require vaccinations will be sent out to the districts clarifying the requirements for athletes, coaches, and spectators.
- Recently, Yonkers released vaccination and testing requirements for athletics. Opponents are seeking clarification from Yonkers on their protocols.
- Winter Championship Site Availability County Center
 - Currently, non-school based venues are unable to commit to our Section Championships. Further discussion will need to occur on potential sites for our winter championships, specifically basketball.
- Commissioner's Determination: Indoor Masking Mandate
 - The new indoor masking mandate applies to indoor sports. In other words, masks are required for athletes, coaches and officials at indoor contests.
- Championship Broadcasting/Streaming Rights Local Live

Discussion:

- Over the last several years, Local Live has had exclusivity to the broadcasting and streaming rights of the Section One finals. The Section earns a guaranteed rights fee of \$15,000 within the exiting partnership.
- Local Live is requesting that the Section consider a different model moving forward. One alternative suggestion is a subscription-based model. Members of the Committee are not in favor of this model.
- o The Committee would like to see greater coverage and equity across all sports.
- The Committee discussed the growth of the company (number of additional schools that Local Live has partnered with) and is interested in a potential increased to the guaranteed rights fees.
- SAT/ACT & Special Events Memo
 - The SAT/ACT & special events memo is being updated. This memo is a reminder that Section, Regional and State Championship dates/times will not be changed. Districts are encouraged to help student-athletes avoid conflicts where possible.
- Status of In-Person Meetings
 - Support was expressed for returning to in-person meetings. Further discussion needs to occur.
- Mackin Requested to review the process for appointing Conference Principal Reps. In accordance with the Section One Constitution, the Conferences (AD's) vote based on the nominations from the Athletic Directors. Currently, the Conference Principal reps are the only group not voted on by their respective

peer groups. A proposal should be drafted and presented to Athletic Council for a potential Constitutional change.
