



Parent Screening Measures-do not send child to school if one or more of the symptoms of COVID are present.	<ul> <li>A child (or employee should be excluded from school if they positive for COVID-19 or exhibit one or more of the symptoms based on CDC guidelines.</li> <li>Symptoms Impacting Consideration for Exclusion from School Include: <ul> <li>A few of 100.4F or greater</li> <li>Cough</li> <li>Shortness of breath or difficulty breathing</li> <li>Chills</li> <li>Repeated shaking with chills</li> <li>Muscle pain</li> <li>Head ache</li> <li>Sore throat</li> <li>New loss of taste or smell</li> </ul> </li> </ul>

Return to school after having one symptom above and testing negative for COVID-19	Return when the fever has been gone for 24 hours without the use of medicine that reduces fever or upon feeling better. Communicate with COVID19nurse@ecps.org.
Return to school after having one symptom above and testing positive for COVID-19 with symptoms	<ul> <li>Notify your school immediately of any positive test. <u>COVID19nurse@ecps.org</u>.</li> <li>Persons who experienced symptoms have been tested positive may return to school if the following conditions are met: <ul> <li>The individual no longer has a fever (without the use of medicine that reduces fever)</li> <li>Other symptoms have improved (for example, when your cough or shortness of breath have improved</li> <li>At least 10 calendar days have passed since symptoms first appeared; or</li> <li>The individual has received two negative tests at least 24 hours apart.</li> </ul> </li> </ul>
Return to school after having one symptom above and testing positive for COVID-19 asymptomatic	Notify your school immediately of any positive test. <u>COVID19nurse@ecps.org</u> .
If someone in your home has symptoms or is being testing for COVID-19	Students and employees should remain home for 72 hours if someone in the household has COVID- 19 symptoms or is being tested for COVID-19. Communicate with the school on status: <u>COVID19nurse@ecps.org</u> .
If someone in your home has tested positive for COVID- 19	Notify your school immediately of any positive test: <u>COVID19nurse@ecps.org</u> . If an individual in one's home has COVID-19 or is isolated because of COVID-19, those in the household should also stay home for a minimum of two weeks. This could be longer if the student becomes symptomatic.
Contact tracing	The local health department will work to determine who has been in close proximity (closer than 6 feet for more than 15 minutes) to trace exposure. SCEC will maintain seating charts for classrooms, buses, and the cafeteria.



Each school's nurse will oversee our comprehensive and integrated plan for monitoring the health and safety of our Cardinals</li> <li>All will practice critical personal safety practices including wearing face masks, enhanced personal hygiene practices including frequent hand washing and sanitizer use, adhering to safe social distancing practices and following all safety instructions and signage.</li> <li>All will keep personal belongings and all learning, studying and working spaces clean.</li> </ul>

	Plan A – Regular School Schedule (Attendance on Campus)
	<ul> <li>On campus learning with the traditional school schedule is accomplished following the CDC guidelines for students who are COVID-19 symptomatic free.</li> </ul>
	<ul> <li>Teachers will provide instruction on a traditional school day schedule.</li> </ul>
	• Technology tools will be used during lessons for this traditional schedule and permit E-Learning students to simultaneously participate. Screen recordings
	of lessons used for students incapacitated.
	• School buildings are open following the CDC guidelines with many additional
	cleaning, safety, and protective measures in place.

	Plan B - E-Learning (Attendance Online)
	• E-Learning Option is available for students/families who are high risk according to the CDC guidelines, which includes: Individuals with serious underlying health conditions, including high blood pressure, chronic lung disease, diabetes, obesity, asthma, and those whose immune system is compromised such as by chemotherapy for cancer and other conditions requiring similar treatment.

Self-Screen Daily	<ul> <li>Staff and students/families must self-screen for symptoms of COVID-19 before coming to school.</li> <li>In Skyward, parents will need to report the existing conditions when calling off a child. To do so, parents will utilize the Absence Requests section in Skyward. In doing so, parents will have options to select the symptom(s) a child is exhibiting and/or have an opportunity to explain such symptoms as they relate to a known medical condition.</li> <li>Staff and students must communicate information to the school when symptomatic.</li> <li>Students and employees exhibiting symptoms of COVID-19 without being otherwise explained by a known medical condition, are prohibited from coming to school, and if they do come to school, they will be sent home immediately.</li> </ul>
Masks	<ul> <li>It is critical to emphasize that maintaining as much social distancing as possible remains important to slowing the spread of the virus. See: What Healthcare Personnel Should Know About Caring for Patients with Confirmed or Possible COVID19 Infection.</li> <li>Notify local health officials, staff, and families immediately of a possible case while maintaining confidentiality consistent with the Americans with Disabilities</li> </ul>

<ul> <li>Act (ADA) and other applicable federal and state privacy laws.</li> <li>Close off areas used by a sick person and do not use before cleaning and disinfection. Implement standard operating procedures while taking protective and preventive measures while teaching.

- Establish 6 ft. distance between the teacher's desk/board and students' desks.
- Identify and utilize large spaces (i.e. gymnasiums, auditoriums, outside spaces as weather permits) for social distancing.
- Providing hand sanitizer for students and staff.
- Safe Materials Handling According to the CDC research, the virus does not live on paper beyond 24 hours. Books with plastic coverings may be disinfected with time and/ or cleaning supplies if deemed necessary beyond a 24-hour time span.
- Desks are separated as much as possible.
- Personal spaces such as desks are wiped with sanitizer wipes by the student who used it before exiting a classroom.
- Designating areas of the hallway (i.e. lanes) to walk to keep students separated (to the extent practicable).
- Custodians conduct cleaning of classrooms and high-touch surfaces each day.
- Custodians will be required to complete cleaning logs in high traffic areas.
- Perfect attendance awards will not be used this school year so as to encourage sick students to stay home.

#### Establish an academic baseline.

- Administer formative assessments toward the start of the school year.
- Conduct meetings with teachers to identify where students are academically.


#### **Regular Schooling**

- Student will be required to attend school (unless they are sick, have or been exposed to COVID-19) regularly and complete all assignments.
- Students will be graded on a traditional scale
- Instructional framework will remain the same: I Do, We Do, and They Do (gradual release)

#### E-Learning

- E-Learning will provide instruction from the teacher.

- Paras will be assigned to classes to monitor and assist students with assignments.
- Students with IEPs will convene to develop their Continuous Learning Plan, or follow the plan if already included in their IEP.
- Instructional framework will remain the same: I Do, We Do, and They Do (gradual release)
- Weekly formative assignment
- Reteach, enrichment, and maintain (REM)
- All I Do and formative assessment must be posted in CANVAS or ZOOM.
