ELIGIBILITY

NYSPHSAA Handbook

#26 Representation Rule

Minimum Number of Contests To be eligible for sectional, intersectional or state competition, a team must have completed in **six (6)** school scheduled contests which occurred on **six (6)** different dates during the season.

Team Sports: An individual is eligible for the team if he/she has been an eligible participant on a team in that sport in that school for a minimum of **(6)** scheduled contests during the regular season.

ENTERING THE SECTIONAL TOURNAMENT

1. The following actions are the responsibility of the school/coach and need to be taken prior to the Seeding meeting. A link and reminders to complete these forms will go out through BOCES to your AD's:
 - a. Officials' Ratings (submitted via Sportspak)
 - b. Non-Preferred Officials (submitted via Google Survey)
2. Schools must keep their schedule and game scores up-to-date on the Section One Score Board platform (www.section1athletics.org). For questions or concerns, please have your Athletic office contact Wanda Maffia in the Section One office at (914) 592-2526.
3. Please check with your Athletic Director if you are not familiar with ScoreBoard.
4. Both schools need to enter the results, as this is a way of confirming the result of the game.
5. The "Section Result" sheet will be pulled by the Section One office on or around the last day to play and be considered the official record for the school. It is extremely important that the schedule and scores included on your "Section Result" page is accurate because you will be attesting to its accuracy for the purpose of seeding. This process has replaced the Game Result Sheet that was used in the past.

NOTE: All games to date must be entered in [Score Board](#) no later than 12:00pm Monday, October 25th. Schools are required to provide the sports chair(s) with the scores and results from games held after the submission of Score Board results.
6. All roster information and team photo, should be updated in Max Preps. NYSPHSAA utilizes both the team photo and official roster from Max Preps for their state championships.
7. All schools must abide by eligibility regulations as set forth in the NYSPHSAA Handbook.
8. Tournament games do not count toward Sectional records. Please do not include them on your Scoreboard "Section Result" page. **NOTE** - Tournaments do count as a contest and are included in the maximum number of contests allowed (20).
9. **Appeals** - An appeal of a school's inability to qualify for the tournament will be accepted up to 24 hours prior to the seeding meeting. The only appeals considered will be districts that have an established policy not allowing teams to participate in a full schedule.

SITES

1. Whenever possible, all matches up to and including the Semi-Finals will be played at the site of the higher seeded team.
2. All sites should be available one hour before the scheduled start. Ball use is permitted on the court 30 minutes prior to the contest.
3. The coach whose gym is being used will be responsible for reserving the gym and having it ready for warm-ups one hour before play is scheduled.

GENERAL PROCEDURES FOR RUNNING SECTIONAL VOLLEYBALL EVENTS

If your school is a host for the 2021 Volleyball Sectional Tournament, there are several responsibilities we are asking you to fulfill in addition to the usual responsibilities that occur during seasonal play. The following is a list of these responsibilities and we ask that you **get as many volunteers as possible**. Also, it is assumed that your school will not charge any money for use of the facilities and any custodians that are needed for the event.

The following is a list of these responsibilities:

Section One Standards

1. COLLECT MONEY AND SUPPLY TICKET TAKERS - Your Athletic Director should have a hand stamp to use on tickets to sell at the tournament. **\$8.00** will be charged for the Finals. **\$5.00 for children 12 & under and Senior Citizens (62 and over).**
2. HOSTS FOR TEAMS AND OFFICIALS - You will need a few people to greet the participating teams as well as officials and show them the locker room facilities and game courts. Protocol for all introductions will include announcing all players and coaches and playing the National Anthem.
3. Clearly outline LOCKER ROOM AND LAVATORY use policies for all visitors.
4. EMERGENCY PHONE NUMBERS - Please have the phone number of your local ambulance and police available in case of emergencies.
5. AN ACCURATE BALL PUMP.
6. Game balls – The Spalding TF-VB5 white, silver & blue ball is required and will be supplied to the host school for the championship event.
7. If official availability allows, the Section will provide each championship game with certified officials to serve as scorer and libero tracker. In the event that certified officials are not available, each team must be prepared to provide an experienced scorer and a Libero scorer.
8. Each team will supply its own first aid equipment. Host schools are encouraged to have a Certified Athletic Trainer on hand for the event.
9. Water for both team benches.

GENERAL PROCEDURES FOR RUNNING SECTIONAL VOLLEYBALL EVENTS Continued **NYSPPHSAA Girls Volleyball Committee Standards**

1. Best efforts to use appropriate music by the home team during warm ups at all sites (for example: songs with negative lyrics geared toward the visiting team would not be permitted).
2. Adults should be at the scoring tables, Neutral adults when possible. Recommended: Officials should be on the lines from Sectional Semifinals and up.
3. It is recommended that teams arrive 45 minutes before match time. A team will not be allowed on the gym floor with volleyballs until 30 minutes before match time. Teams will be allowed on the floor to warm up/stretch prior to the 30 minutes without volleyballs.
4. Official warm up is 23 minutes on the clock - Officials meet with team representatives and will signal when to start the clock for warm ups. Start clock after coin toss

23-19 mins	4 minutes shared time (whistles at 19:15 & 19:00)
19-15 mins	Visiting team has exclusive court use (whistles at 15:15 & 15:00)
15-11 mins	Home team has exclusive court use (whistles at 11:15 & 11:00)
11-6 mins	Visiting team has exclusive court use (whistles at 6:15 and 6:00)
6-1 mins	Home team has exclusive court use (whistles at 1:15 and 1:00)
1-0 mins	Pick-up volleyballs and during the final minute

PROTEST PROCEDURES

For all of the sectional matches, protests must be lodged according to NCAA rules. If the match officials deem that the controversy is protest-able, a formal protest must be lodged (play will continue after the lodging of the protest); then the protest is called/delivered/faxed to the Section One Chair by 8 pm on the day of the protest. After reading the protest, the Section One Chair will confer with the Volleyball Official's Chair. The Section One Chair's decision will be final. If the protest is upheld, the match will be replayed on the next day, from the point of protest.

PRE-GAME INFORMATION

1. Each team will provide an experienced scorer and a Libero scorer. The higher seed will provide these officials.
2. Each team will supply its own first aid equipment.

POST-GAME PROCEDURES

1. The **winning coach** is responsible for calling in the game results by 8:00p.m. on the day of the match. Classes AA, A and D, please call Diane Swertfager at (914) 649-2440. Classes B and C, please call Robin Cooke (914) 804-2396.
2. **Publicity**-All coaches will be responsible for calling their own papers and radio stations with results and facts about their match.
