## AMENDMENT TO AGREEMENT ON TERMS AND CONDITIONS OF EMPLOYMENT BETWEEN LEE LEW AND THE BOARD OF EDUCATION OF THE TUCKAHOE UNION FREE SCHOOL DISTRICT

This Agreement made the \_th day of April, 2020 by and between the Board of Education of the Tuckahoe Union Free School District (hereinafter the "Board") and Lee Lew (hereinafter "Ms. Lew") is hereby entered into as an Amendment to the Agreement on Terms and Conditions of Employment between them dated the 4th day of April, 2016 (hereinafter the "April 4, 2016 Agreement").

WHEREAS, the Board and Ms. Lew have entered into an Agreement relating to the terms and conditions of Ms. Lew's employment, dated April 4, 2016; and

WHEREAS, the Board and Ms. Lew have entered into amendments of the April 4, 2016 Agreement, specifically an agreement dated June 12, 2017 and an agreement dated June 18, 2018; and

**WHEREAS**, the Board and Ms. Lew wish to amend certain provisions of the April 4, 2016 Agreement, as amended;

**NOW, THEREFORE,** in consideration of the promises and mutual covenants contained in this Amendment and the service rendered to the District to date, it is hereby agreed as follows:

- Ms. Lew shall rescind her letter of resignation for the purposes of retirement, which
  was to become effective on June 30, 2020.
- Ms. Lew shall submit a letter of resignation for the purposes of retirement, such
  resignation date to be June 30, 2021, at the same time as this Agreement is executed by
  her.

- 3. The Board of Education agrees to consider a recommendation by the Interim Superintendent to grant Ms. Lew tenure at its Board meeting on April 21, 2020. The parties agree that should Ms. Lew be denied tenure by the Board at the April 21, 2020 meeting, Ms. Lew shall be allowed to rescind her letter of resignation for the purposes of retirement to be effective on June 30, 2021 and resubmit her letter of resignation for the purposes of retirement to be effective on June 30, 2020.
- 4. The compensation paragraph in her current Agreement is amended to read as follows:
  "Compensation. For the period from July 1, 2020 through June 30, 2021 the
  Assistant Superintendent for Business' salary shall be One Hundred and Eighty-Nine
  Thousand (\$189,000) Dollars. Ms. Lew shall be paid in twenty six (26) equal installments at regular intervals effective July 1 and ending on June 30."
- 5. All other terms and conditions set forth in the April 4, 2016 Agreement, as amended shall remain in full force and effect.
- 6. This Amendment to the Agreement is subject to and contingent upon its approval by the Board of Education.
