<u>Discussion</u>: Locally, we have hit a critical point of needing certified officials to provide the opportunity to offer interscholastic athletics to our student-athletes. There have been collaborative conversations with the leadership of our local chapters identify ways to recruit new officials. NYSPHSAA launched a school based official program last year. In addition, they are working to help identify why so many officials are leaving the field. One of the major reasons is the spectator behavior and how they are being treated as professionals in their role as officials. Lastly, NYSPHSAA is also working on streamlining the certification process for modified officials.

<u>Discussion</u>: The idea behind creating this policy was to give both district Superintendents and Athletic Directors guidance on what the expectation is of the districts should there be a violation of a protected class. This would give guidelines and help identify what a thorough and prompt investigation looks like and what the key components and expectations are of the district.

The Athletic Council felt the policy read like a DASA document and suggested removing that language. The majority were in favor of the sportsmanship announcements to make all aware of the expectations at our contests. Legal counsel had also reviewed the initial document, and felt it read more like a DASA policy rather than a DEI policy. Dr. Baiocco discussed the private schools are not beholden to DASA and this is the reason the DASA language is referenced in the policy.

There was support expressed by the Committee to adopt such policy. There was agreement that the document should be available and communicated to coaches before the Fall season begins.

The Athletic Council has had discussion regarding whether sanctions should occur as the result of these unsportsmanlike incidences. The schools involved have reported no additional consequences.

• Reported Racial Incidences

There have been reports of recent racial incidents amongst several member schools. Most recently, the Section Office received a report regarding an incident earlier this spring during a girls lacrosse game between Westlake and Ossining. Westlake has shared findings of their investigation along with the work they are trying to plan collaboratively with the two teams/schools.

As a result of recent incidences between Nyack and Pearl River, the Section Office received a memo from the Nyack Public Schools requesting that the Section One Athletic Council grant forfeitures against Pearl River, in all sports, at all levels for the 22-23 school year. This request will be heard by the Athletic Council at an upcoming meeting.
