

REQUEST FOR TRANSPORTATION TO A NON-PUBLIC SCHOOL

At this time, for <u>NEW</u> requests for transportation services please email the District Registrar, Erin McMahon (<u>emcmahon@klschools.org</u>) for instructions for submitting required documentation.

- To be eligible for transportation, students must be five years of age on or before December 1st of the year in which they are requesting transportation services.
- A Request for Transportation to a Non-Public School form must be completed in its entirety.
- A separate form must be completed for each student.
- All forms must be submitted to the District Registrar, by April 15, 2020 to be eligible for transportation services beginning in September 2020.
- An original birth certificate and residency documentation to verify residency within our District boundaries are also required when applying for new student transportation services. (We will make copies of your documents when you submit your application.) Specifically, two (2) proofs of address within the Katonah-Lewisboro School District are required. Proofs of residency include:
 - Document indicating current home ownership such as Deed, or Mortgage Statement, or recent Tax Bill, or signed and dated Lease
 - AND either: Driver License or recent Utility Bill
- The New York State Education Law mandates that a written request for transportation to a non-public school must be filed each year with the District in which you reside.

All requests received by April 15, 2020 will be reviewed by our office. If your child/ren is eligible for transportation services by the Katonah-Lewisboro School District to a non-public school, you will receive a letter in August with details regarding route location and bus times. If your child/ren is not eligible for transportation services by the District, you will receive written notice of this decision in June.

To request transportation services for a <u>RETURNING</u> student, please submit the Request for Transportation to a Non-Public School form directly to the Transportation Office by email, fax or mail (see contact info at the bottom of the form).

REQUEST FOR TRANSPORTATION 2020 – 2021 SCHOOL YEAR
