WHEREAS, The Telecommunications Act of 1996 is administered by the Federal Communications Commission, which issued the rules that govern this act; and WHEREAS, One part of this statute established a Universal Service Fund, known as the E-Rate Grant Program, that allows schools and public libraries to apply for discounts for telecommunication services and technologies, with awards depending on the demographic characteristics of a community; and WHEREAS, the Mt. Pleasant Cottage School UFSD is eligible to apply for and receive an E-Rate award (discount) to cover up to ninety percent of the cost of internet service, Hardware and Maintenance services. All public bidding was completed in compliance with Federal Regulations where all E-rate vendors are able to review the services requested and submit a bid for the district to review and consider.

NOW, THEREFORE, BE IT RESOLVED that the Board of Education approve the award of the E-rate bid to Red River Technologies LLC in the amount of \$43,915.76 for switches cabling and installation and \$13.964.46 for long term maintenance and licensing.
