What is Dual Enrollment?

Dual Enrollment is Georgia's program that allows high school students (9th - 12th grade) to earn college credit while working on their high school diploma. The dual enrollment program covers tuition, mandatory fees and required textbooks. The goal of dual enrollment is to increase college access and completion, and prepare students to enter the workforce with the skills they need to succeed.

Tattnall County dual enrollment policy:

To participate in the dual enrollment program through TCHS:

- 1) The student must be a high school student.
- 2) The student must meet the testing requirements (SAT, ACT or ACCUPLACER) and other admission requirements of the college or university that will sponsor the courses.
- 3) The student must be on track to graduate.
- 4) The student and parent must meet with the school counselor to discuss the MOWR program and courses in detail.

Frequently Asked Questions:

o If I am planning to take English 1101 and 1102 courses, do I still have to complete my summer work for AP English/Lit? *No. If you plan to take English 1101/1102 you will no longer be enrolled in AP English/Lit at TCHS.* (NOTE: you only have to take English 1101 to satisfy your senior English credit. However, it will be beneficial towards college to take English 1101/1102),

- Juniors taking English 1101 must take both English 1101 and English 2130 to meet the 11th and 12th grade English requirements.
- What will I do during the period where the college evening class is showing on my schedule? We will do our best to schedule these periods back to back so that you can come in late and leave early or vice versa. Please keep in mind that everyone's situation is different. For example, some of you leave early for work while others stay all day. We will do our best to accommodate you and your requests, but if we are unable to do so, you will report to the library during this designated period (s). This will be a wonderful opportunity for you to work on your assignments for your MOWR classes. There will be no roaming around the school during this period. You must stay in a designated area!
