(I) NYSPHSAA Student-Athlete Leadership Conference

With more than 50 applicants a criterion was established to assist in narrowing down who would be invited to participate.

During the Spring of 2022, Todd Santabarbara and Jesse Merchant were invited to a meeting with the Mayor of Mount Vernon and her staff. As a result of that meeting, Todd coordinated a site visit with representatives from Mount Vernon and several Section One Sport Chairs.

Westchester County Center

To examine the status of the renovations prior to considering the adoption of a contract for the 22-23 basketball championships, Todd coordinated a site visit with representatives from Westchester County and the Section One officers. The Officers provided thoughts and feedback To the Executive Committee regarding the improvements and renovations being completed at the County Center. There was interest by committee members to pursue a reasonable multiyear contract for the next 3 years as part of the RFP process.

(I) Overview of agenda items for the February 1st NYSPHSAA Executive Committee meeting

Discussion:

The NYSPHSAA Budget/Audit Committee is amending their proposed increased to NYSPHSAA membership dues. The proposed increase is \$1000/school and \$1/student (above 300) in grades 7-12. These adjustments are in part due to increased costs associated with their championship events as well declining attendance at championship events. The NYSPHSAA dues have not been increased in over a decade.

Several NYSPHSAA sub-committees have been formed to address various membership concerns. The Combining of Teams, DEI and Transfer Committees will all be scheduling times to meet in February and March. Section One will be represented on each of these committees.
