Sign-in for Public Comment begins at 5:45 p.m. and ends at 5:55 p.m. Guidelines for addressing the Board during Public Comment are as follows:

- 1. You must register in person the night of the meeting. Registration is open between 5:45 p.m. and 5:55 p.m.
- 2. The opportunity to address the Board at each regular Board meeting is 30 minutes at the beginning of the meeting.
- 3. Each speaker has three minutes.
- 4. A designated Board Member will maintain a stopwatch and notify the speaker when they have 15 seconds remaining.
- 5. Speakers' individual comments will be stopped at three minutes.
- 6. Speakers may not ask questions of Board Members.
- 7. Speakers may discuss issues, not individuals.
- 8. Board Members may not engage speakers in discussion.
- 9. Disruptive behavior is not permitted.
- 10. Personal attacks aimed at students or staff is not permitted.
- 11. Scurrilous, obscene or recklessly defamatory language aimed at any Board Member is not permitted.
