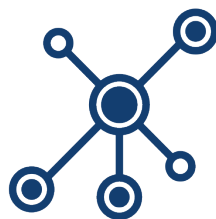

Deborah A. Snyder serves as Chief Information Security Officer (CISO) for New York State, in the Office of Information Technology Services (ITS). In her role, she oversees the Enterprise Information Security Office, and directs a comprehensive program of governance, risk management and compliance functions, vulnerability management, threat intelligence, cyber incident response, and training and exercise services. She provides strategic leadership and vision, and assuring business-aligned, risk-based investments that maximize business opportunity and minimize information and cyber security risk.

Ms. Snyder has extensive experience in government program administration, information technology and cyber security policy. She actively supports the State's efforts to engage citizens and enhance the delivery of government services. She is an acknowledged industry thought-leader, and has been recognized for excellence and outstanding contributions in public programs and the field of cyber security.

She serves on the NYS Forum Board of Directors, NY CISO Executive Summit Governing Board, is a State Academy for Public Administration Fellow, and member of the Project Management Institute, InfraGard, Information Systems Security Association (ISSA), Information Systems Audit and Control Association (ISACA), and the Institute of Internal Auditors (IIA). She teaches graduate-level courses, has published numerous articles, and co-authored "SECURE – Insights From The People Who Keep Information Safe," which offers industry leadership insights and perspective. She is a highly regarded speaker on topics critical to executive-level business and IT professionals.



Temitope Akinyemi

Temitope Akinyemi is the Chief Privacy Officer at the New York State Education Department. In this role, she oversees the Information Privacy and Information Security programs and is responsible for the development and implementation of the department's data privacy policies and practices.

Ms. Akinyemi is leading the effort to fully implement New York's Student Data Privacy Law, Education Law §2-d to protect the privacy of students and teachers across the State. She has worked diligently with stakeholders to develop regulations which will promote the least intrusive data collection policies practicable while advancing academic achievement, empowering parents with information and facilitating efficient and effective school operations.

Ms. Akinyemi is an experienced attorney with a background that includes negotiating multi-million-dollar information technology transactions and investigating public inquiries and complaints as an attorney and the Privacy Compliance Officer at the NYS Office of Information Technology Services. Prior to her State service, Ms. Akinyemi served as an attorney at Anderson Byrne.

Making Informed Decisions about What Your School Needs

School safety has drastically changed over the last 20 years.

Threat Vulnerability and Risk Assessments (TVRA) and Active Shooter Preparedness Training for School Districts

In this presentation we will explain the process taken to build a Threat Vulnerability and Risk Assessment for a school, including the typical findings and benefits that districts receive, from an unbiased review. We will also discuss how best to prepare for an active shooter scenario.

An independent TVRA provides school districts with a critical review of a facility's security profile, as well as specific actions that can be taken to harden the security, train the staff and secure the safety of the occupants. A TVRA also provides an element of liability reduction in that it clearly demonstrates a proactive approach to safety and security.

In the Active Shooter Preparedness section of the session, we will review the history of active shooter events and discuss what can be expected, based on the historical record. Attendees will receive a "Lessons Learned" presentation from the Columbine High School and Parkland, Florida, High School shootings. We will also provide information on how to respond to a violent incident, including how to employ multi-option responses if encountering an active shooter.

If a hazard, threat or emergency occurs at school it is essential that key school personnel are capable of communicating effectively. School administrators, teachers, security personnel, and other school employees must be able to make appropriate decisions and lead effectively in order to protect everyone entrusted to their care. Safety at school starts with having adequate emergency management communication capabilities. This training is designed to provide school officials with an overview of emergency management communications. Participants will gain a better understanding of the critical role communication plays during a crisis. They will become familiar with their roles and responsibilities as it pertains to sending and receiving information during emergencies. Participants will learn how technology can be used to reduce risk, protect people, and coordinate district-wide safety initiatives.

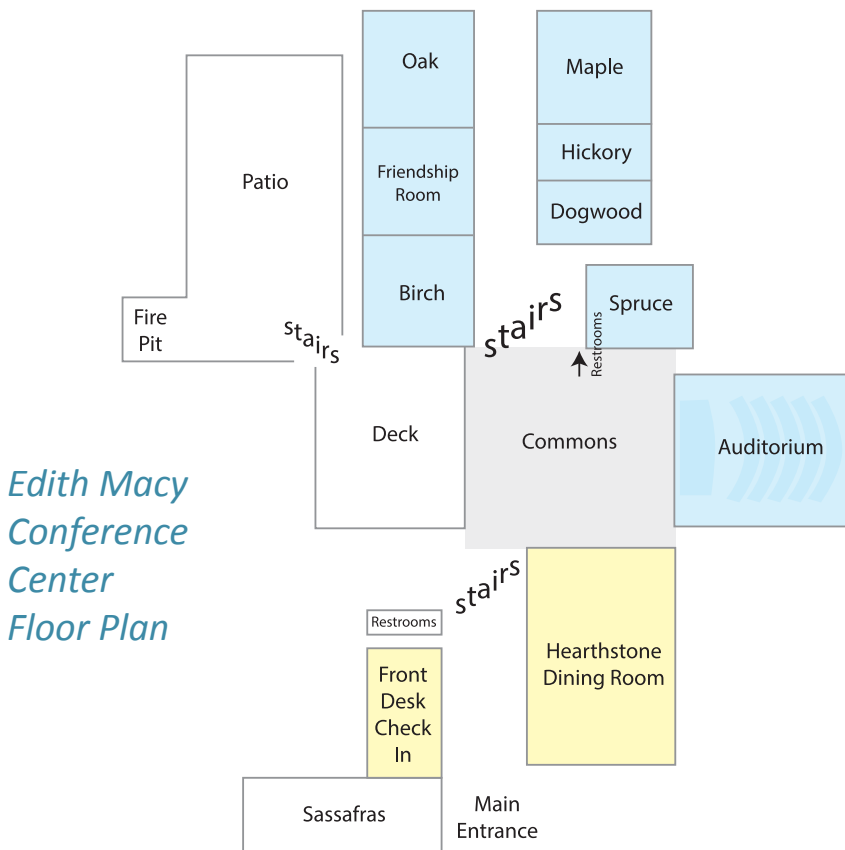
