Enclosed is a packet containing the necessary material for prospective school board candidates:

1. Qualifications for Membership on School Board
2. Statements of Campaign Expenses and Affidavit Form
3. Blank petition for Nomination for School Board Members (a minimum of 29 qualified voters required)

**Signed petitions for prospective school board candidates are to be filed with the District Clerk no later than Monday, April 18, 2022, by 5:00 p.m. When submitting the petition to the District Clerk, please include a signed letter stating that the names and addresses of the persons listed on the petition are those of qualified voters of the Port Chester-Rye Union Free School District.**

Candidates are required to file Expense Reports with the District Clerk according to the calendar below:

1. First Statement is due thirty (30) days before election, April 18, 2022.
2. Second Statement is due no later than five (5) days before the election, May 12, 2022.
3. Third Statement must be filed within twenty (20) days after the election, June 6, 2022.

Lots for position on the ballot will be drawn on Tuesday, April 19, 2022, in the District Clerk's office at 10:00 a.m. In the event any candidate is not present or is not represented by a person designated in written proxy, the District Clerk is authorized to act as proxy.

Registration of voters will take place at the District Office located at 113 Bowman Avenue on Monday, May 9, 2022, from 2:30 p.m. – 6:30 p.m.

Election of School Board Members will take place on Tuesday, May 17, 2022. Voting will take place in each of the four (4) designated election districts from 7 a.m. to 9 p.m.

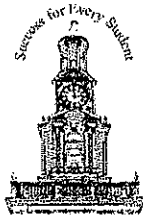

**QUALIFICATIONS FOR NOMINATION OF CANDIDATES FOR SCHOOL BOARD**

1. Candidates for the office of member of the Board of Education must meet the following criteria:
  - a. Must be able to read and write.
  - b. Must be a qualified voter of the district, is a citizen of the United States, and at least 18 years of age or older.
  - c. Must be and have been a resident of the district for a continuous and uninterrupted period of at least one year.
  - d. May not reside with another member of the same school board as a member of the same family.
  - e. May not simultaneously hold another incompatible public office.
2. Candidates shall be nominated by petition. Such petition shall:
  - a. Be signed by at least 29 qualified voters of the district.
  - b. State the name, residence, email address and telephone number of the candidate.
  - c. State the residence of each signer.
  - d. State the term of office.
3. Each petition shall be filed with the District Clerk no later than 30 days prior to the school meeting or election at which the candidates so nominated are to be elected.

**NOTE:** Lots for position on the ballot will be drawn 1 day after filing deadline.

## **STATEMENTS OF CAMPAIGN EXPENSES**

**Chapter 359 of the Laws of 1978 (revised 1981), provides that all candidates for the Board of Education must file sworn statements of campaign expenses.** Statements are properly filed when postmarked within the time indicated below.

**Campaign Expenses Over \$500** (Itemized expenditure statement is required)

First Statement at least 30 days preceding the election.

Second Statement on or before the 5<sup>th</sup> day preceding the election.

Final Statement must be filed within 20 days after the election.

**Campaign Expenses Under \$500**

Instances where a candidate incurs little or no personal expenditures and/or if expenditures incurred by other with his approval are minimal, a sworn statement must be filed indicating the election expenditures did not exceed \$500. No other campaign expenditure statement is required.

## Board of Education Candidates

### New York Education- Article 32- § 1529 Times for Filing Statements

§ 1529. Times for filing statements. 1. The times for filing the statements prescribed by section fifteen hundred twenty-eight of this article shall be as follows:

a. A first statement shall be filed on or before the thirtieth day next preceding the election to which **it** relates.

b. A second statement shall be filed on or before the fifth day next preceding the election to which **it** relates.

c. A third statement shall be filed within twenty days next succeeding the election to which **it** relates.

2. Unless otherwise provided, each statement shall cover the period up to and including the day next preceding the day herein specified for the filing thereof; provided, however, that any contribution or loan in excess of one thousand dollars, if received after the close of the period to be covered in the last statement filed before the election but before such election, shall be reported, in the same manner as other contributions, within twenty-four hours after receipt.

3. It shall not be necessary to itemize in any statement the data previously reported in any prior statement but each statement shall include a summary of all expenditures and contributions and other particulars reported in any previous statements.

4. A statement shall be deemed properly filed when deposited in an established post-office within the prescribed time, duly stamped, registered and directed to the clerk of the school district in which he is a candidate and to the commissioner of education, but in the event it is not received, a duplicate of such statement shall be promptly filed upon notice by the school district administrative officer and/or the commissioner of its non-receipt. Each statement shall be preserved for a period of three years from the date of filing thereof and it shall constitute a part of the public records and shall be open to public inspection.
