The Westchester/Putnam Boys & Girls Basketball Chapter are refusing to follow the NYSPHSAA protocols related to the Commissioner's Determination regarding weekly COVID testing. Todd has been in conversation with Todd Nelson and Steve D'Angelo. If the Association does not comply it could result in either only utilizing vaccinated officials or requiring the schools to check proof of testing and/or vaccination upon arrival each day.

 - (D) Six Classification Proposal NYSPHSAA Ad-Hoc Classification Committee
 - Dr. Robert Zayas reported the following to the Athletic Council

There has been an update to the vaccination mandate at Ocean Breeze for the Indoor Track and Field Championships. Ocean Breeze sent out a notification stating they have removed the vaccination mandate for student athletes participating in that venue. The vaccination mandate remains in place for coaches and spectators.

The Ocean Breeze mask policy states student athletes must always wear a mask other than when

they are participating. However, an individual venue policy cannot supersede the directive provided by the DOH to the school districts where masks at indoor settings are required at all times.

As of right now, there is no position to advocate for a change to the mask policy from the membership.

There has been about the same amount of attendance if not more attendance at state championships. Covid is not keeping people from attending the events.

The amount of criticism and complaints seem different than prior to the pandemic. There seems to be zero tolerance for anything other than what parents want and they are not taking no for an answer. Parents are going above and beyond now that athletics are back.

All 32 officials' organizations have agreed to abide by the DOH guidance by only assigning officials that are in compliance by being fully vaccinated or by submitting a weekly test.

February 2^{nd} is the scheduled vote for the changes to the classification format and the criteria to be developed for the 6 classifications.
