The newly adopted deadline of December 11th, 2023, for a school to declare independence in the sport of football was shared. The new protocols were adopted by the Athletic Council in part to better align the football scheduling process with meeting the contractual deadlines for officials while respecting the demands and procedures of the scheduling process. Dan Belfi shared concerns about the 2-year commitment that is built into the proposal and that the proposal did not receive conference feedback.
