

**SUMMERVILLE ELEMENTARY SCHOOL DISTRICT****STUDENT INTERDISTRICT ATTENDANCE CONTRACT**

Pursuant to the provisions of Board Policy 5117, Administrative Regulation 5117, and Education Code sections 46601, my/our child (If more than one child, complete a separate contract for each child) has been granted an Interdistrict Attendance Permit to attend the Summerville School District by virtue of the District of Residence and the Receiving District's approval of an Interdistrict Attendance Agreement.

I/We understand and agree that the Summerville School District Superintendent may revoke this Interdistrict Attendance Permit during the school year upon the occurrence of any of the events listed below even if I/we have other children attending pursuant to Interdistrict Attendance Agreements:

1. The student engages in any misconduct, including, but not limited to, the violation of law, school or school directives, whether or not such misconduct constitutes a violation of Education Code section 48900, et seq.
2. The student fails to maintain satisfactory record of attendance including timely attendance.
  - A. No more than 10 unexcused absences during a school year.
  - B. No more than 5 unexcused tardies during a school year.
3. The student fails to maintain a grade of "C" or "S" or better in all his or her classes. The receipt of a grade of "D," "F," "U," "Needs Improvement," "Incomplete," or "No Mark" are all considered unsatisfactory grades and grounds for revocation of the Interdistrict Attendance Permit.

I/We understand and agree that it is my/our responsibility to provide transportation for my child to and from Summerville School District. I/We understand and agree that my/our child is to be picked up from school following the dismissal from class no later than \_\_\_\_\_ p.m. unless he or she is under the direct supervision of a teacher for a specified school-related activity such as band, athletics, leadership, etc.

I/We understand and agree that the District may place my/our son or daughter in a particular class within the District at its discretion, and that the District may make this placement after consideration of the availability of space in a class or at a school. I/We further understand and agree that the District may change this initial placement as it determines what is in the best interest of the student population as a whole within a particular grade or program.

I/We understand and agree that I/we must annually renew this Interdistrict Attendance Agreement (See, form E-5117) and resign a new Interdistrict Attendance Contract.

I/We understand and agree that the failure of me/us, my son, or my daughter to abide and follow these conditions on a daily basis may result in the unilateral recession of the Interdistrict Attendance Permit anytime during the school year for which the Permit was approved and may

necessitate my/our child returning to the District of his or her residence even if I/we have other children attending Summerville School District on an Interdistrict Attendance Permit.

I/We understand that I/we do have the right to appeal to the Governing Board the Superintendent's decision to revoke my/our son or daughter's Interdistrict Attendance Permit.
