Dear Mr. Russo,

RegCom completed a limited water testing throughout the district in April 10, 2016 and several sampling points were above the EPA Action Level. Following the investigation, the district remediated several sinks and water fountains. RegCom retested the following sampling points on July 22, 2016. The sampling points were below the EPA Action Level with the exception of the kitchen sink #3 as indicated below.

The following options are recommended for the kitchen sink that failed on the first draw and fell within compliance on the second draw (following a 30-second flush):

- Flush the water system in the building and retest the sink/water fountain or
- Set up a "flushing" schedule, so that the sinks are flushed for >1 minute each morning prior to use (the process should be documented) or
- Replace faucet.
