A) APPROVAL – WITHDRAWAL OF PARTICIPATION IN RACE TO THE TOP PROGRAM

WHEREAS, Dr. Susan Guiney, Superintendent of Schools and the Board of Education of the Mount Pleasant Central School District believe it to be in the best interests of the School District and the members of its school community to withdraw its participation under the New York State Education Department Memorandum of Understanding for participation in the Race to the Top federal grant-in-aid program; and

WHEREAS, pursuant to guidance from the New York State Education Department, the District has fulfilled the following requirements for such withdrawal (i.e., compliance with all applicable State or Federal laws or regulations, including the requirements of Education Law Section 3012-c and Subpart 30-2 of the Regents Rules, filing the currently unsubmitted Final Expenditure Report, Annual Program Report and the 1512 quarterly report for the period ending September 15, 2013);
