The Board met for Executive Session at 6:00 p.m. in the Teachers Room to discuss pending litigation. Mrs. Capeci called the meeting to order at 7:18 pm and the pledge of allegiance was recited.

PRESIDENTS OPENING REMARKS

Mrs. Capeci greeted everyone at Park Avenue School. Mrs. Capeci acknowledged former Port Chester High School Graduates Katie Glockenberg, Class of 2001. She attended Harvard and then medical school, went on to Columbia Presbyterian to complete her residency and now has a fellowship at Sloan Kettering. Lee Glockenberg, teacher, is her sister and also a PCHS graduate. Brother Luke is a PCHS graduate, class of 2010.

Dr. Kliszus read aloud student names for AP Scholar Recognition and students received their recognition certificates.

Mrs. Rosa Taylor, Principal of Park Avenue School presented the school report.

Mrs. Brakewood thanked Mrs. Taylor.

Mr. Dreves acknowledged Park Avenue School challenges and made mention of all the challenges the Port Chester Schools have in comparison to our neighboring districts. He commended Park Avenue School for a job well done.

Mr. Johnson stated "Always great to be here at Park Avenue School". His son has wonderful memories of his experience at Park Avenue School

Mrs. Capeci expressed her appreciation for a school and noted that is well kept and in excellent condition. It is a wonderful environment to be in and children want to be there.

PUBLIC COMMENT

George Ford – Quintard Drive. The teachers have a lot of work cut out for them with Common Core. Mr. Ford reflected on last public comment at the November 20th meeting. He wants to make it clear that the goal in speaking about taxes is not to gut the schools. The issue has nothing to do with politics. Mr. Ford expressed his inability to afford his school tax bill. Mr. Ford discussed the non residency issue in Port Chester. He asked about the re-registration costs associated with the process and noted that he had inquired with the Ossining School District who recently conducted a re-registration.

Liz Rotfeld – Betsy Brown Road. Thanked Mrs. Capeci for acknowledging a former graduate who attended Harvard. Mrs. Rotfeld spoke about the benefits of working together as a community and not write negative letters to the press and School Board.

Mr. Fanelli stated that he meets with Mr. Acevedo and Mr. Guinta almost every day. Mr. Fanelli gave a residency update. Port Chester completes physical checks vs. paper audits only. There is a minimal amount of students found. Mr. Fanelli stated there are multiple steps taken and the process is difficult in addition to lengthy. We as a District must follow the appropriate legal steps.

Dr. Kliszus stated the current enrollment of 4400 students and the historical high was 4800.

Mr. Ford shouted from his seat with comments and left the meeting abruptly. It was unclear what was stated to the public because Mr. Ford was

not at the podium while speaking.

Mrs. Charlene Tobin – Hidden Falls, Port Chester. She stated that the problem is that taxpayers are overburdened. She blamed the Board to refuse to enforce residency laws. She accused the district of stonewalling the taxpayers for a re-registration. She asked why won't the district conduct a re-registration? Mrs. Brakewood commented that the current process is a form of re-registration. Mrs. Tobin said the numbers do not add up. Port Chester is a 2.4 mile square village with 4400 students and it does not make sense.

Mr. Dreves commented on the potential illegal housing that is in place within the village. Mrs. Tobin left the meeting and Mrs. Capeci asked to continue with the Treasurers report.

At the request of Dr. Kliszus, prior to reading Resolution H, Maura McAward, Assistant Superintendent of Schools presented a presentation on the lack of funding received from Foundation Aid. In looking at the pool of 8 districts underfunded from the expected Foundation Aide, the Port

Chester School District is ranked one the highest underfunded school districts in all of New York State with an annual increasing enrollment. Since 2007 Port Chester has only received 48% of their Foundation Aid. Poverty and enrollment is what drives Foundation Aid. We have been underfunded since 2007 in the amount of 85 million dollars. There are districts in New York State that has been overfunded because of decreased enrollment which is not the case for Port Chester.

Dr. Kliszus along with the PTA representatives have drafted an advocacty letter that is also available on the district web site. Mrs. Brakewood read the letter out loud. Dr. Kliszus then read the resolution.

Upon motion by Mr. Johnson, seconded by Mr. Dreves and carried, the following resolution was adopted:

Resolution to Promote Equitable School Funding that Complies with New York State's Constitutional Mandate and Every Student's Right to A Sound, Basic and Quality Education Under State and Federal Law

- **H. WHEREAS**, The Campaign for Fiscal Equity (CFE) undertook the mission to enforce the constitutional rights of all New York schoolchildren to a sound, basic and quality education;
- WHEREAS, CFE filed a lawsuit claiming that New York State was underfunding New York City's public schools and thus denied students their constitutional right to the opportunity for a sound, basic education;
 - WHEREAS, in 1995, the New York Court of Appeals ruled that CFE made a valid claim and remanded the case for trial;
 - WHEREAS, in 2003, the Court of Appeals upheld the ruling that the State's school funding system violated schoolchildren's constitutional right to a sound, basic education;
- WHEREAS, in 2007 the Governor and Legislature recognized the constitutional obligation to all children in New York State and passed statewide funding reform;
- WHEREAS, the law enacted a Foundation Aid Formula designed to ensure adequacy and equity in state school funding by establishing a relationship between state aid, the needs of students and a district's ability to raise revenue;
 - WHEREAS, The State froze Foundation Aid Formula at 2008 school aid levels;
 - WHEREAS, School Districts with decreasing enrollment and student needs have benefited from the freeze;
- **WHEREAS,** in the first two years, the Legislature provided installments of the Foundation Aid Formula, however, in 2009, aid was frozen at 37.5% of the four year target and cut by \$2.7 billion in 2010 and 2011;
 - WHEREAS, the Governor and Legislature adopted a budget process that prevents full funding of the 2007 Foundation Aid Formula;
 - WHEREAS, the implementation of Foundation Aid is not adhering to the principles upon which it was designed;
 - WHEREAS, as a result of the current implementation of Foundation Aid, some school districts are receiving more than 100% of their
 - aid and other districts are receiving funding levels well below an amount deemed adequate for the provision of a sound, basic education;
 - **WHEREAS,** the Port Chester-Rye Union Free School District received only 48% of its Foundation Aid; and is the fourth lowest Foundation Aid funded district in New York State;
- WHEREAS, the Port Chester-Rye Union Free School District has seen an increase in student enrollment since 2008 ranking first among ALL Districts in NYS that have experienced an INCREASE in student enrollment AND have been underfunded in Foundation Aid;
 - **NOW, THEREFORE, BE IT RESOLVED** that the Port Chester-Rye Union Free School District calls on Governor Andrew Cuomo, Also, the Port Chester-Rye Union Free School District is requesting that Foundation Aid be unfrozen for School Districts seeing increases in enrollment and that are underfunded.

WHEREAS, the school district is hampered by and the taxpayer is burdened by inadequate state funding and unfunded state mandates;

WHEREAS, the school district has successfully kept tax increases within the state calculated tax levy cap; and

NOW, THEREFORE, BE IT RESOLVED that the Port Chester-Rye Union Free School District calls upon the Villages of Port Chester and Rye Brook to discourage additional large scale residential developments within the area known as Port Chester-Rye UFSD because it will increase student enrollment in our schools, exacerbate overcrowded classrooms, increase school taxes, and potentially diminish student achievement.

Ms. Capeci reminded everyone of the Village Liaison meeting the next day. We have the right as a school district has the right to acquire land by condemnation.

Dr. Kliszus thanked people for their tips on non-resident students. The work of Mr. Acevedo is thorough. One of the most important things the community could do right now is to write the legislators for the lack of funding received in Port Chester. Letters should be written and examples are found on the District Website. The energy and passion should be directed to Albany.

Board of Education Roundtable / Discussion

Mr. Dreves discussed the topic of the meeting with NAACP. A demographic balance is important among our teachers and the Board will pay attention to the conversation had with the NAACP.
