Dear Parents,

The Community Women's Club of Level Green is once again sponsoring its annual Safety Town program this summer. Safety Town 2021 will be held **June 14**<sup>th</sup> – **18**<sup>th</sup> at the Level Green Presbyterian Church from **9:00 – 11:30 a.m.** Children who are entering kindergarten for the 2021 - 2022 school year are eligible to attend, **as well as children attending 1**<sup>st</sup> **grade** due to the cancellation of last year's program.

The Safety Town program is designed to teach basic safety measures, tips, and awareness lessons that will keep children safe. Fun and learning will be combined to promote the importance of personal and community safety.

Key topics will include fire safety, school bus safety, poison awareness, stranger danger, and bike/scooter/skateboard safety. Visits will be made by the Penn Township Police Department, Penn Township Ambulance, Level Green Volunteer Fire Department, First Student Bus Company and information on summer safety / first aid. The children will also be introduced to the "Town" and will have an opportunity to learn about street safety as they drive big wheels or bikes with training wheels through the Town each day during the program. **Personal bike helmets are required.** During the week we help teach the children their full name, address, and telephone number for use in emergency situations. In addition, the children will enjoy crafts, snacks, songs, workbooks, and new friendships daily.

Weather permitting, previous indoor activities of Safety Town will be held outdoors in order to maintain social distancing.

Registration deadline is **Sunday May 23<sup>rd</sup>**, but space is limited to 45 students (3 classes of 15). Spots are filled on a first-come first-served basis. Avoid the waiting list by registering early!

The Community Women's Club of Level Green has sponsored this program for almost 40 years. We believe in better educating our children to develop a safe community. If you have any questions regarding our program, please call.

- 3. **PHOTO:** A recent photo of your child is needed at the time of registration (it will be returned to you). It will be used for identification purposes at pickup each day.

# **COVID19 PROTOCOLS:**

TO MAKE SAFETY TOWN A STRESS FREE AND ENJOYABLE EXPERIENCE FOR ALL CHILDREN IN ATTENDANCE AS WELL AS THE VOLUNTEERS, ALL CURRENT STATE REGULATED GUIDELINES WILL BE FOLLOWED DURING SAFETY TOWN 2021. UPON SIGNING YOUR REGISTRATION FORM, PLEASE NOTE THE FOLLOWING PROTOCOLS WILL BE IN PLACE DURING OUR EVENT. IF THERE ARE ANY CHANGES THEY WILL BE POSTED ON SITE AND AVAIABLE TO YOU AT THE START OF THE PROGRAM:

- MASKING OF CHILDREN IS AT THE DISCRETION OF THE PARENT OR GUARDIAN.
   WE WILL NOT TURN AWAY NOR REQUIRE ANY CHILD TO WEAR A MASK OR SHEILD.
- NO MEDICAL DISCLAIMER FOR NOT WEARING A MASK IS NECESSARY
- ALL VOLUNTEERS WILL WEAR A SHIELD OR MASK WHEN APPROPRIATE
- WE WILL NOT REQUIRE ANY COVID19 NEGATIVE TESTS OR TEMPERATURE CHECKS
- ALL TABLES, SUPPLIES, BIKES, PROPS, EQUIPMENT AND COMMON SPACE AREAS AND RESTROOMS WILL BE THROUGHLY CLEANSED AND SANITZIED REGULARLY AND AT THE END OF EACH DAY
- ALL FOOD ITEMS WILL BE INDIVIDUALLY WRAPPED OR SERVED. THERE WILL NOT BE ANY BUFFET LINES OR SHARED FOOD CONTAINERS
- IF YOU OR SOMEONE IN YOUR HOUSEHOLD IS EXHIBITING COVID19 SYMPTOMS, AND YOUR CHILD HAS BEEN ATTENDING THE PROGRAM, WE ASK THAT YOU REFRAIN FROM SENDING YOUR CHILD TO SAFETY TOWN.
- IF YOU REGISTER FOR SAFETY TOWN AND PRIOR TO JUNE 14, 2021, YOU OR SOMEONE IN YOUR HOUSEHOLD IS EXHIBITING COVID19 SYMPTOMS, PLEASE DO NOT SEND YOUR CHILD/CHILDREN TO SAFETY TOWN. CONTACT US FOR A FULL REFUND. REFUNDS WILL NOT BE HONORED IF YOUR CHILD BEGINS THE PROGRAM AND THEN IS REMOVED DUE TO COVID19 ILLNESS.
