Count is down from last year and hopefully this will be the trend for the remainder of the school year. The Fine Arts Grant program is up and running. He is still working on finding good deals on laptops for the Low Cost Laptop Grant. The playground area needs some upgrading and that will be a project that will be handled in the near future.

HIGH SCHOOL REPORT

Ms. DeBerry informed the board about the progress of the school year so far. FFA (Future Farmers of America) is going to Indianapolis Oct. 19-21. There are about 10 students going on this trip. The CNA program is doing well. There are 14 students currently enrolled in this program. It is being worked out where these students may be able to receive college credit for this program. High School students took part in a survey to help better Meridian school district. There were some interesting outcomes as to what areas the students felt needed improvement.

21ST CENTURY AFTERSCHOOL ENRICHMENT PROGRAM

Mrs. Houston gave a brief update on the 21st Century Afterschool Enrichment Program. The program began Tuesday, October 11th. There are currently approximately 220 students involved in the afterschool program for Elementary and approximately 40 students involved from High School. She is trying to come up with some incentives to get the High School students interested.
