#### ADMINSTRATIVE

- Staff training begins next week as we implement distance learning at the start of the new school year; Dr. Ly will be breaking up staff into small groups to do training mostly via Zoom or Google Meets or in in-person. We will work to keep as many people out of the building as possible.
- Audit starts today through August 26; final interview on the 26 and we are ending school year with a good fund balance. Last year there was a slight hiccup with filing financials with MDE and it didn't get submitted right away on time through no fault of our own. As such, we did not earn a MDE Financial Award. Due to that error, we switched auditors for this year.
- All staffing needs have been filled—two new 7<sup>th</sup> grade teachers on board
- Facility-wise we are just putting final touches on new building
- Lease aid in process; we are waiting on letter of approval from City of Saint Paul inspector and fire marshall

# **ACADEMICS:**

- Open house has been cancelled alongside other activities. In lieu of that, teachers are setting up
  meetings with parents and students to build an initial connection. We may be meeting with them
  outside of the building.
- We are working on getting new Chrome Books ready for students and we are hoping to have them by 9/13 and then have parent meetings the following week in-person. Tech plan set to go into action on October 1, 2020.
- We will be delivering food and learning packets to students right away when school starts every Tuesday.
- All learning plans and policies in place on website.

#### **OPERATIONS**

We will continue to run buses as is for this year; slight increase of approx.\$11/bus/day; \$60K increase overall to budget

#### **COMMUNITY:**

 Outreach for student recruitment going well; lots of new students have applied online with our new application. We have received 30 students that applied online, which is great news and was unexpected.
