## N. Audience Participation

Mr. Charles Herman, Councilman updated the Board on the FEMA generator grant. He had a further conversation with Mr. Testa and obtained clarification that the size of the generator may be tailored to operate the school at the School Board's discretion. He further clarified that the school may obtain a smaller generator within the FEMA grant amount and present this proposal to FEMA. Also, the use of the building would be to primarily shelter our students; 99.9% for student use; and very rare for the county or state to take over a building. The Board agreed to revisit the use of the FEMA funding to purchase a generator for the school.
