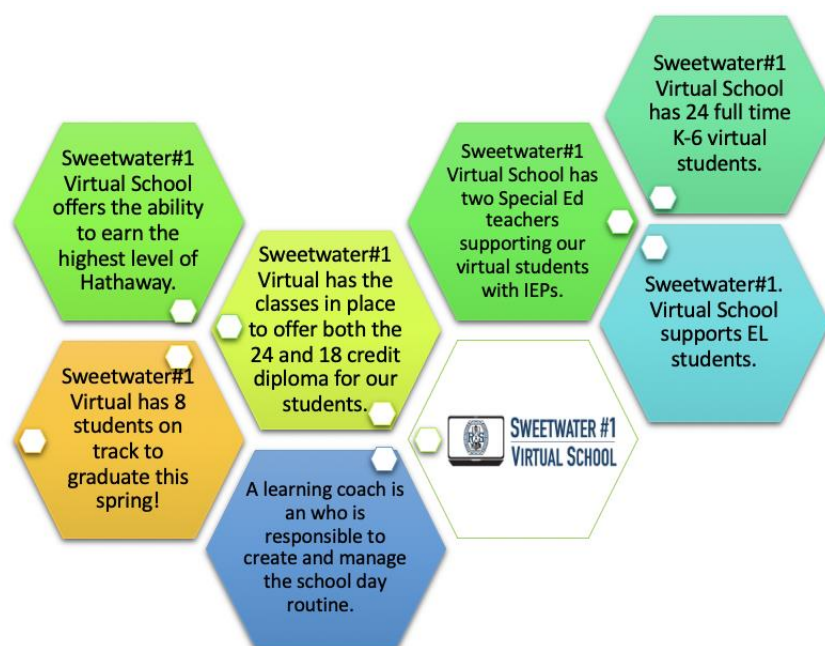

CCC & SAC Update

The Community Curriculum Council (CCC) met in October and reviewed/updated the CLI model, the curriculum quick guide, curriculum procedures and membership. Also, the CCC began the work on recommending the secondary standards based grading. The committee also worked on constructing a mastery statement for Sweetwater#1 and started a book study on "Grading from the Inside Out". With the adoption of the 4 day work week, teachers are seeing the need to modify curriculum maps, proficiency scales and assessments. Subject Area Committees (SAC) are focusing on identifying priority standards (boulders), writing proficiency scales and aligning common assessments to match revisions. WY-TOPP blueprints, where applicable have been used to inform the curriculum changes. The SAC teams that have met so far this year include CTE, ELA, Math and Computer Science. Compensated additional evening time has been offered to all SAC teams to complete the work—additional opportunities will be available second semester and in the summer. About 50 people have participated in the additional work to date. With the changes, K-6 report cards will be updated using the newly revised benchmarks. Computer Science Standards

A group of K-12 teachers came together to unpack the [Wyoming Content and Performance Standards for Computer Science](#). The team dug into the standards, which are grouped in grade bands, and assigned potential grade levels where the teachers will teach to mastery. The team created standards walls which propose where standards will be taught. At the next meeting, the team will make, review and revise the walls before starting to write draft curriculum maps. WY-TOPP Data

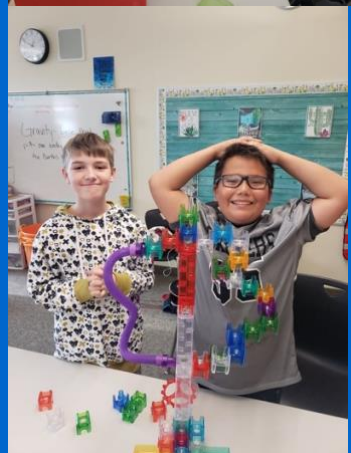
The WY-TOPP is the state assessment that measures reading, writing, math and science. The WY-TOPP test wasn't given during the Spring of 2020 but was readministered the Spring of 2021. The 20-21 WY-TOPP assessment data has been released to students and schools last month. The data is available by [clicking here](#).

Parent Involvement for Student Achievement (PISA)

A committee consisting of 15 parents/community members, 7 teachers, 6 administrators, 5 district staff and 3 school board members met during September of 2021 to review data, generate questions, brainstorm solutions and recommend ideas on how to improve student achievement. The team analyzed WY-TOPP, Acadience, ACT, Climate and Culture data and generated questions. The themes that appeared after reviewing data and generating questions included: Instruction and Learning, College/Career Readiness and Job skills, Culture & Climate, Innovation and Post-Pandemic: Functioning in a Changing Society and Moving Forward, Leadership: Taking Risks and Community Partnerships & Service: Giving Back. Groups were then involved in a gallery walk where input from every person was charted. The teams then chose two high-impact strategies to be voted on by the group and consensus was reached. The group chose the following goals to work on:

- Build relationships with parents and community involvement
- Define priority standards and teach all students to mastery
- Embed purposefully planned relationship building in schools and classrooms

Action plans are being written by sub-committees and the draft plans will be forwarded to the Principal PLC, the Cabinet and the Sweetwater#1 Board of Trustees for action.



Gifted & Talented Update

The Gifted and Talented program has a new teacher this year, Kalista Pendleton. Welcome Kalista! Kalista administered an interest survey and is getting to know each student, discovering their interests and passions. She is helping her students set short and long term goals and monitor progress towards meeting their learning goals. She is busy developing a class culture of learning, community and working together as a team.

The Gifted & Talented program will continue to screen 2nd grade students to identify possible candidates for the program. This will take place in May of 2022. This change in practice began the second semester of the 2020-2021 school year and has been very beneficial at identifying students with special talents.

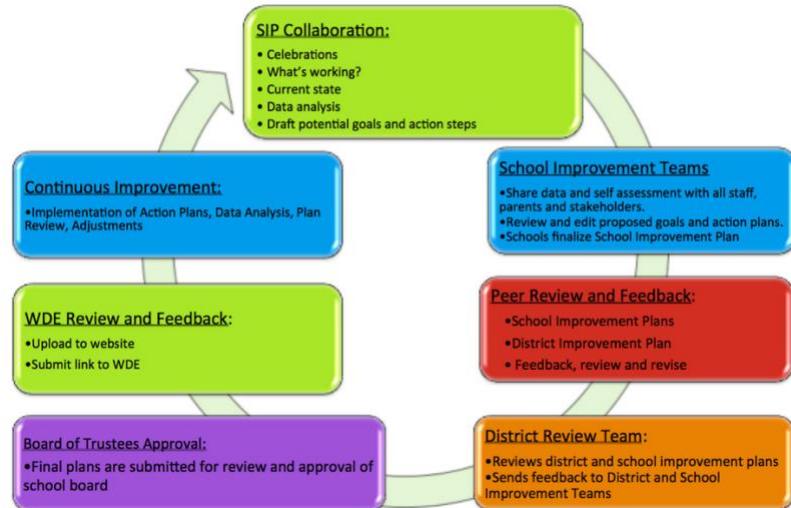
Gifted and Talented classes for 7th and 8th grade students began this Fall of 2020 at RSJH. The class (Gifted and Talented) is an elective class and will provide additional support and advanced learning opportunities for students in Sweetwater#1. The GATE I course is offered as an elective to identified gifted students. This course uses interdisciplinary units combining nature and the four other core education areas, along with creative and fine arts, technology, and engineering. It is designed to help students develop learning skills in areas such as collaboration, critical thinking, communication, and creativity through high interest, problem-based units.

Currently, the 3rd- 6th grade Gifted and Talented program in Sweetwater #1 is a pull-out program. Services are also provided to students in 7th and 8th grade. The students in grades 3rd-6th leave their regular classrooms for the day and meet at Eastside Elementary to learn with other gifted and talented students from other schools in the district. Students in 7th and 8th grade register for a class and are meeting throughout the week.

The students have been engaging in engineering projects, STEM projects as well as participating in challenges. Sweetwater #1 Continuous School Improvement Process



School improvement teams met during August and September to review data, discover celebrations and areas that need work. Sweetwater#1 is piloting a new template from WDE that all schools in Wyoming will be using next year. WDE valued the input from Sweetwater#1. The teams drafted plans, participated in peer reviews, made changes and submitted them to the Board of Trustees for review and approval. Welcome Our New At-Risk Oversight Coordinator!



We are excited to introduce Annie Fletcher, who is our new At-Risk Oversight Coordinator! Annie is in her 25th year in education and has found that this new position has been a refreshing return to roots; advocating for and supporting students and families in challenging situations. The start of the year has seen a primary focus on our youth in transition. Over the course of

the 2020-21 school year, SWSD #1 identified 66 students as in transition. To date, with the help of our building liaisons and school secretaries, we have identified 35 students that meet the criteria for students in transition (homeless). The past few months, Annie has been busy working to provide support for our identified families. This included gathering school supplies, supporting families in getting the necessary registration paperwork, as well as partnering with the school foundation for school clothes, and working with the community to find stable housing, food, and fill other basic needs. Next, we are excited to announce the award of funding for Wyoming's Project Aware, cohort two, a mental health-focused outreach program funded through SAMHSA (Substance Abuse and Mental Health Services Administration of the Federal Department of Health). Sweetwater School District #1 will be one of three districts identified for support through this grant. Over the course of a five-year grant cycle, Annie will work to provide direct student access to licensed mental health providers while continuing to work on increasing our stakeholders' knowledge and awareness of mental health concerns in our community. We are excited to see the positive impact this support will have on our students.

Parenting Partners



During September teams from four of our K-3 buildings and the district came together for a Parenting Partners instructors training. [Parenting Partners](#) focuses on building positive parenting skills by leveraging the collective parenting knowledge of the facilitators (that include parents) and the participants. The project, funded through Title I, aims to move parent involvement and engagement to an all new level; moving beyond meetings and parent nights to truly partnering with families to support other families who can in turn support even more families.

Stagecoach elementary bravely began first, they will have completed the six sessions just before Thanksgiving. So far, lessons have included building volcanos to demonstrate how arguments with our kids escalate as we add more and more until BOOM!; and learning to use a “shield” to deflect attempts of others to create or escalate conflict . All of the groups are excited to continue to integrate this new learning into our district, continuing to build capacity in our community.
