SAC Update

The Math and Health/PE Subject Area Committees (SAC) will meet during the months of September through December to write common assessments aligned to the benchmarks within the curriculum. Common assessments will be implemented district-wide and validated during the 2017-2018 academic year. The assessment development process supports measuring students' proficiency in meeting the benchmarks, guides instructional planning, and ensures consistency of curriculum implementation. The SCSD#1 long-range plan assists in identifying the year each component of curriculum mapping, adopting resources and assessment development occurs.

Data Teams: Make Data Impact Instruction

This summer, administrators, instructional coaches and teacher leaders attended a three-day training to become certified Data Teams trainers. The purpose of this data teams training was to build leadership capacity to support PLC teams using the data teams process. Data Teams is a collaborative model for implementing data-driven decision making at the instructional level. The data team process allows teachers to identify areas of student need and collaboratively decide on the best instructional strategy to use to teach the deficit skills and concepts as well as extend the learning of other students. The power of the data teams process is to identify effective strategies and classroom practices that increase student proficiency. Throughout the school year, PLC teams will use the Data Teams process with common assessments. Administrators, instructional coaches and teacher leaders will be available to support this process.

MAP Testing on iPads

This school year MAP testing will available on the iPads at schools. This can be helpful for K-1 students when taking the primary test, which often requires the students to touch and drag a selection to another space on the screen. Using the iPad to MAP test will also be helpful by being able to enlarge the screen for students that have this accommodation on an IEP.

Students should have a basic understanding of how to manipulate the iPad to make the testing process easy on the student.

New iPads automatically have the MAP app added to them, but existing iPad labs may not have the app loaded. If you intend to use iPads to test students, please put in a helpdesk ticket for Stacie Smith to make sure she has time to update the iPads if they don't have the app already. Stacie said this could possibly take a few days so please plan accordingly.

MAP Reports Training

Watch for a District News email to hit your inbox in mid-October containing dates and info for MAP reports trainings. The trainings will review reports, leaving time at the end for Q & A.

Optional Compass Testing

Compass testing is an optional interest inventory and college placement assessment. Students must be given the opportunity to take this test during the window (Oct. 3-21), but are not required to take this assessment.
