Call to Order

- * In order to be granted tenure, a classroom teacher must receive composite or overall annual professional performance review ratings pursuant to Education Law §3012-c and/or §3012-d of either effective or highly effective in at least 3 of the 4 preceding years. Further, if the classroom teacher receives an ineffective composite or overall rating in the final year of the probationary period he/she shall not be eligible for tenure at that time, in which case the Board of Education, in its discretion, may extend the teacher's probationary term for an additional year.
- 22. CONSIDERING AN INTER-MUNICIPAL AGREEMENT BETWEEN THE VILLAGE OF RYE BROOK, THE TOWN OF RYE AND THE PORT CHESTER-RYE UNION FREE SCHOOL DISTRICT TO PARTICIPATE AND REQUEST FUNDING FOR A FLOOD MITIGATION STUDY

A. WHEREAS, the area along the eastern Branch of the Blind Brook in the Village of Rye Brook between the Rye Ridge Condominiums known as Avon Circle and the lower pond on Bowman Avenue has historically experienced significant flooding and negatively impacted and caused damage to both residential properties and Port Chester Middle School properties; and

WHEREAS, the Village of Rye Brook, the Town of Rye, and the Port Chester-Rye Union Free School District have received a Flood Mitigation Study proposal from Dolph Rotfeld Engineering, P.C. dated July 14, 2016 (the "DRE Study") to seek ways to improve these flooding conditions; and

WHEREAS, the DRE Study would evaluate flooding conditions in the vicinity of Avon Circle as well as downstream areas including Bowman Avenue and the vicinity of the athletic fields immediately west of the Port Chester Middle School building; and

WHEREAS, the DRE Study proposal fees for Phase 1 and Phase 2 are estimated to be \$95,000.00 for investigation survey, hydraulic modeling and preliminary engineering, which includes \$7,500.00 for non-flood mitigation improvements at the Port Chester Middle School; and

WHEREAS, in 2011 Westchester County adopted a Stormwater Management Law and developed a program whereby funding is available to eligible municipalities for flood mitigation or flood damage reduction projects if such projects are included in the reconnaissance plans prepared for each major drainage basin; and

WHEREAS, flooding and the need for a flood improvement project in this area has been identified in the Westchester County Reconnaissance Plan for the Coastal Long Island Sound Watershed (August 2013) making the vast majority of the DRE Study eligible for municipal funding assistance through the Westchester County with the exception of the \$7,500.00 for non-flood mitigation improvements at the Port Chester Middle School which is also included within the study; and

WHEREAS, the Village of Rye Brook, with the support of the Town of Rye and Port Chester Union Free School District, has submitted a *Stormwater Management Law Flood Mitigation Project Application Form* to the County of Westchester seeking 50% of the costs of Phase 1 and 2 of the DRE Study in an amount not to exceed \$50,000; and

WHEREAS, the remaining 50% of the costs would be shared as follows: Rye Brook 25% (up to \$25,000), the Town of Rye 12.5% (up to \$12,500), and the Port Chester-Rye Union Free School District 12.5% (up to \$12,500); and

WHEREAS, the Village of Rye Brook has prepared an inter-municipal agreement for the consideration of the Village of Rye Brook, the Town of Rye, and the Port Chester-Rye Union Free School District outlining the obligations of the Village of Rye Brook, the Town of Rye, and the Port Chester-Rye Union Free School District for this cost sharing commitment and coordination of municipal and school district efforts (the "IMA"), as more particularly described in the IMA; and

WHEREAS, the Village of Rye Brook, on behalf of the Town of Rye and the Port Chester-Rye Union Free School District, would further agree to coordinate and take the lead municipal role on the Westchester County stormwater application and project coordination with Westchester County, including the approval of a separate inter-municipal agreement between the Village of Rye Brook and Westchester County for Westchester County Phase I stormwater funding of this project; and

Board of Education Roundtable / Discussion

Mrs. Capeci gave a shout out to John Ruggiero, who is a 1979 High School graduate and works for the Bureau of Public Health in the County. They are going after the mosquitos and are looking out for the health of the children.

Mr. Wolff talked about the many success stories of our high school graduates, which goes unnoticed and are not told loudly enough. The Pre-K Program is a great positive, as well as the new Community School Coordinators who can help acclimate the children. We have a great school system and we need to get the word out more. There is a new automated system for the lunch program for paying for lunches, and there is a new website; both are beneficial to our families.

Mrs. Brakewood said that My SchoolBucks.com is the school lunch program, an idea which was brought up by parents in the district. You can put money into the account and/or you can monitor what your child's purchases even if you are on free and reduced lunch. Another website is the Athletics website which is useful for finding out more information about the sports going on in the District. She also spoke about the pre-season sports going on, the first home football game, cheerleading camp and band camp. First day is Tuesday, September 6th for the children. Mrs. Brakewood also mentioned the Math, ELA and Science test scores that are being received and is hoping that the school's reports will include any influencing factors regarding the outcome.

Mr. Johnson gave a shout out to Mr. Vitti, the high school band director who is recovering from a serious illness. The athletes are here learning on the field before they enter the classrooms. The state-mandated heat advisory system is in effect with a protocol that is followed. Mr. Johnson was at a meeting with Nita Lowey with representatives from NYSSBA and talked about foundation aid and many other items. He went to Albany and worked on the resolutions committee and there is a legislative committee meeting next week. He thanked Bob Miller and Dale Williams for the Midnight Run program they started, which Mr. Johnson participated in New York City. The board mentioned that we might try and look more into possibility bringing a similar program to our District. There was further discussion on state testing and scores tied to teachers' ratings.
