Why should a school examine PBIS (SWIS) Data?

When you focus on ways to sustain PBIS practices, including sharing your data, you turn a flash-in-the-pan initiative into something more deeply rooted with lasting positive impact. It is required that SWIS data be reviewed at least quarterly by each school within the district.

A recent study of 860 schools across 14 states (McIntosh, Kim, Mercer, Strickland-Cohen, & Horner, 2015) looked at the schools' demographics as well as the teams' actions to see which factors increased the likelihood of sustained SWPBIS implementation. Turns out, it was the team's actions, specifically how often it shared data with all school staff, that had the most significant impact on whether the school sustained its implementation.

It is always a good time to remember the positive impact sharing data with staff can have on achieving the valued outcomes in your building. When the whole school understands the goals and sees progress from the efforts, everyone is more likely to embrace the interventions implemented to meet those goals. The best way to share data is the way that feels most natural, leads to effective decisions, and offers opportunities for everyone to engage in planning.

Within this newsletter, I have shared first semester District SWIS data. This data was compiled utilizing individual school core reports dated August 1, 2018 to December 21, 2018 as well as suspension data. For data to be beneficial it is essential that it not only be shared but also utilized. As you review this data, as with your individual school data, don't hesitate to drill down.


To complete a drill down

- 1. Search for specific student related red flag item.
- 2. Analyze what, where, when, who, why.
- 3. Generate a referral summary.
- 4. Generate a precise problem statement.
- 5. Generate a goal/solution.




District SWIS data Referrals by Location





District SWIS data Referrals by Problem Behavior




District SWIS data Referrals by Time
