This appointment requires Ms. Harkness to obtain secondary math certification by August 31, 2020. Ms. Harkness holds a permanent certificate in Pre-Kindergarten, Kindergarten and Grades 1-6 Education. Salary is per the salary schedule contained in the 7/1/13-6/30/18 collective bargaining agreement with the Long Lake Faculty Association.
