# Port Chester - Rye Union Free School District Reorganization Meeting Port Chester High School July 5, 2011

The Reorganization Meeting of the Port Chester-Rye Union Free School District Board of Education was held on Tuesday, July 5, 2011 at 7:30 p.m. in Room 229 at the High School.
