BE IT RESOLVED: That the Board of Education herewith adopts and authorizes a certain Memorandum of Agreement between the Mt. Pleasant Central School District

and the Civil Service Employees Association, Inc., Local 1000, AFSCME, AFL-CIO, Westchester Local 860, Mt. Pleasant Custodial Unit, for the period of July 1, 2012 through June 30, 2015.

BE IT FURTHER RESOLVED: That the Board of Education authorizes its attorneys to incorporate said Memorandum of Agreement into a successor collective bargaining agreement.

WHEREAS, it has been determined that there is an operational need to eliminate one (1) full-time title in the Facilities Department.

NOW THEREFORE, BE IT RESOLVED that the Board of Education hereby abolishes the position of Superintendent of Buildings and Grounds effective April 25, 2014.

BE IT FURTHER RESOLVED, that the Board of Education of the Mount Pleasant Central School District, upon the recommendation of the Superintendent of Schools, hereby creates the 1.0 (FTE) position of Director of Facilities III.

BE IT FURTHER RESOLVED, that the work year for said position shall be July 1<sup>st</sup> through June 30<sup>th</sup> and the job duties of said position are held with the Westchester County Department of Human Resources.

BE IT FURTHER RESOLVED, that the Board of Education, upon the recommendation of the Superintendent of Schools, herewith provisionally appoints Edward Kear to the position of Director of Facilities III effective April 28, 2014.

BE IT FURTHER RESOLVED that said appointment is contingent upon the drafting and executing of an acceptable employment agreement between Edward Kear and the Board of Education of the Mount Pleasant Central School District.
