Graduation Rate Up for SCSD#1


Newly released graduation rates from Wyoming Department of Education (WDE) indicate that Sweetwater County School District #1 (SCSD#1) has increased 3.75% for the four-year "on-time" graduation rate. The district increased from 73.31% in the 2014-2015 academic school year to 77.06% in the 2015-2016 academic school year.

As far as individual district high schools go, a 20.44% jump was seen in the graduation rate at Black Butte High School (BBHS). Last year BBHS graduated 59.46% of it's students in four years, up from 39.02% the previous academic year. An increase of 1.59% was seen at Rock Springs High School (RSHS) graduating 78.82% of students. Farson-Eden High School (FEHS) had a 9.85% decrease from the 2014-2015 academic school year for a graduation rate of 81.82% for 2015-2016.

SCSD#1 had a graduation rate of 65.88% in 1996. The graduation rate for the 2015-2016 academic school year was 77.06% and the district is continuing to see an upward trend in the graduation rate.

All grade levels can affect graduation rate by helping students feel welcome at school, know the importance of attendance, and understand the affect education can have on the rest of their lives.

The ELA/EL Resource Adoption Committee will hear presentations from each publisher on February 15, 2017 and make final recommendations on February 28, 2017.



December 22nd PD Survey Results

Instructional Facilitators and Teacher Leaders facilitated the December 22nd professional development. This half-day training focused on completing instructional planning within departments and K through 8th grade math teachers learned more about how to use Eureka

Math modules. Survey results indicated most people who responded to the survey agreed the training met the targets and was well planned and delivered. Some respondents felt the their knowledge increased as a result of the training. Most respondents found one or more strategies that could be used in their position and that the instructional planning time was beneficial.



School Improvement Plans Accepted by Wyoming Department of Education

On January 5, 2017, WDE sent acceptance letters to each school in SCSD#1 stating their Comprehensive School Improvement Plan was reviewed and they "meet the requirements of W.S.21-2-204(f) and is formally accepted by the Wyoming Department of Education."

Each school received feedback from WDE ensuring all indicators were evaluated, effective practices documented, practices and indicators in need of improvement addressed, assurances verified, and plans written addressing WAEA performance indicators. WDE also checked that measures and methods addressed the school's goal, interventions, timelines and benchmarks were correctly stated as well as an evaluation system of interventions. Title I

Title I, part of the Every Student Succeeds Act (ESSA) of 2015, is a federally funded supplemental program that provides extra funding to schools with a higher percentage of children from low income families. Title I schools are identified based on the percentage of students who qualify for free/reduced meal plans.

on February 1, 2017. The count includes students in all public schools as well as private and home schools. Private and home school students are included in the count based on their public school attendance area.

The percentage of students in each school eligible for free/reduced lunch is used to determine which schools are eligible for Title I funds during the 2017-2018 school year. Final determination of Title I status is made after the district receives Title I allocation information (usually in July/August). Funds are then distributed using a formula based on the number of low-income students in eligible schools. Visit the SCSD#1 Title I webpage for more information.

February ACCESS Testing

Thank you to all teachers and principals for supporting the district's English Learner Teachers as they administer the Assessing Comprehension and Communication in English State-to-State for English Language Learners, (ACCESS for ELLs) over the next month to determine English proficiency. The testing window opened January 24th and will end February 28th. All students identified as limited English proficient participate in the ACCESS test. This includes students who do not receive services due to refusal. English Learner teachers at each school will work with classroom teachers and administrators to develop a testing schedule to support completion of the ACCESS test during the testing window.

Cardboards to take home! The night ended with pizza and prizes. Thanks to WWCC and Google for making this night possible!



NAEP Testing

Education is crucial for ensuring children will have the knowledge and skills necessary to be productive members of the global economy. However, to know if the nation is succeeding in it is vital to have impartial information about what students know and can do, whether their performance has improved or declined, and which factors may influence this performance. The National Assessment of Educational Progress (NAEP) is uniquely designed to provide this information.

Established in 1969, NAEP (also known as the nation's report card) was created to provide a common way of measuring the progress of students' education across the county. Results from state testing are not directly comparable due to the differing standardized assessments used by each state. NAEP asks the same questions in every state, making comparisons possible. NAEP also uses questionnaires to gather data on educational practices of students and schools to give context to the assessment data. By using this system long-term NAEP trend data allows today's students to be compared with those from the early 1970's in math and reading.

The NAEP testing window opened January 30th and runs through March 10th. This assessment is scheduled and administered by NAEP representatives and is completely voluntary for students. NAEP is only reported at the state level. In fact, NAEP is forbidden by law to maintain or report individual school or student information.
