On May 15, 2018, we hope you will join us to vote on the 2018-2019 Katonah-Lewisboro School District budget and the election of two Board of Education trustees.

This newsletter provides you with valuable information about the proposed budget, how it will support the education of our students, and how it will impact you and our community. We are proposing a budget that we believe maintains our community's commitment to excellence in education and carefully weighs the need for fiscal responsibility.

Proposed spending will increase next year by less than 2%. Despite a \$1.2 million increase in health insurance costs next year, we are once again presenting a budget that is below the New York State tax levy cap. Dear KLSD Community,



With spring's arrival, we turn our thoughts to graduations, transitions, and planning for next year. Despite the many weather-related delays and closings, our students had another excellent year. They built musical instruments and award-winning robots, completed sophisticated science research, put on shows to make Broadway jealous, and raced through a new cross-country course of their own creation.

Our teachers and administrators learned together. Our driving force was and will be the KL Learning Commitment, with a particular focus this past year on intellectual engagement. We expanded our work with Teachers College, Columbia University in support of writing. Sixteen teachers are completing their first year in a two-year innovation grant cohort. At our high school, we are studying and implementing performance-based assessments, intended to further learning rather

than interrupt it (as traditional assessments can do).

Next year's budget will support our students and staff as they work together to prepare our students for a rapidly changing future. We know the skills our students

## POINTS OF PRIDE FROM THE 2017-18 SCHOOL YEAR







### **Athletics**

- Thirteen teams received Scholar-Athlete Team Awards for at least 75% of the team having a composite GPA of 90% or better.
- Women's Cross-Country won States. One runner is #1 in Westchester County.
- Women's Soccer team is co-League champion. Their coach was named Coach of the Year.
- Women's Swim and Dive is undefeated League Champion. Ten members qualified for NYS Championships: two are Academic All-Americans.
- Seven members of the Men's Swim and Dive team qualified for NYS Championships.
- The Ice Hockey team is Sectional and NYS Regional Champion. Their coach was named Coach of the Year.
- Two wrestlers were crowned Section champs and placed 2nd and 5th at the NYS Championships.
- · Women's Basketball won the League title.
- Men's Skiing won the Section title. Four John Jay skiers qualified for the Championship. Three qualified for the Eastern High School Alpine Ski Racing Championships.
- One athlete earned the prestigious Con Edison Award.

### **Music and Art**

- Elementary students explored art with educators from the Katonah Museum of Art and The Aldrich Museum of Contemporary Art.
- Elementary students learned about the design process as they created musical instruments, illustrated ecosystems, mixed paint, and built vehicles.
- Sixty-six students across the district participated in New York State School Music Association (NYSSMA) Festivals.
- Fourteen students were selected to participate in All-County Band, Orchestra, or Choir, and four in All-State Festivals.
- A student-musician has been accepted into New York University's Future Music Moguls high school program.
- The high school vocal jazz ensemble attended the Berklee High School Jazz Festival in Boston.
- More than 200 students brought energy and excitement to the middle and high school's theater productions.

## **Humanities and More**

- All elementary school students gained mindfulness techniques to raise focus and lower stress.
- Published children's book authors spoke to elementary school students about the writing process.
- Sixth graders enjoyed art and cooking enrichments to world languages, social studies, and math classes.
- The middle school's Geography Bee winner qualified to compete at the New York State National Geographic Bee.
- The middle school—on the recommendation of a New York State Senator—participated in a program that nurtures student leaders to encourage their peers to make healthy choices.
- The high school's Peer Group leadership program celebrated fifteen years.
- The high school's Mock Trial team advanced to the Westchester County semi-finals.
- Five high school seniors are National Merit Scholarship Finalists.
- John Jay High School was designated a No Place for Hate School by the Anti-Defamation League.

#### Science and Math

- Students from all three elementary schools and the middle school explored an area of interest for their annual science fairs.
- The middle school's MATHCOUNTS club had record participation in the MATHCOUNTS competition at Pace University and the MoMathlon at Manhattanville College.
- The middle school hosted a STEM Assembly in which parents spoke to students about careers in science, technology, engineering, and math
- Nine high school students participated in the Westchester County Science and Engineering Fair. All won awards. One student is a semi-finalist in the prestigious Siemens Competition.
- The high school's Science Olympiad team brought home two medals from New York State's competition.
- John Jay's robotics team won the regional championships at Pace University and competed at the US FIRST Super Regional Championships.

## **PROPOSITION NO. 1: KLSD BUDGET**

The first proposition on the ballot is the Katonah-Lewisboro School District's operating budget for the 2018-19 school year. The proposed budget supports and strengthens the outstanding academic program offered within the Katonah-Lewisboro School District while being fiscally responsible and under the property tax levy cap.



## **PROPOSITION NO. 2: BUS REPLACEMENT**

In addition to the general fund budget proposal, you will have an opportunity to weigh in on a proposition to transfer funds from the 2017-18 general fund to the capital fund to replace seven 20-passenger vans, one seven-passenger minivan, and two 66-passenger school buses. If approved, there would be no impact on taxes and no additional debt would be incurred.

The 10 vehicles to be replaced have an average of 212,000 miles on their odometers and are between 12 and 13 years old. The cost of the minivan is \$24,800. Each van costs \$50,900 and the school buses each cost \$114,800.

The replacement of buses and vans on a rotational basis is very important to maintaining safe, dependable transportation. Each of the district's vehicles is inspected by the NYS Department of Transportation twice a year. Our decision to replace the vehicles is based on the inspectors' insights.



KLSD Transportation Department washes all school buses regularly to keep road salt from causing rust. The dirty water is captured on a mat and suctioned into a holding tank to prevent groundwater contamination and protect the wetland area.



## **VOTER INFORMATION**

All voters registered with Westchester County are automatically registered to vote in their school district's budget and school board election. If you are not registered to vote, you may register at any of the schools in the district or at the District Office between the hours of 9 a.m. and 3 p.m. on regular school / business days, as well as at the District Office on Saturday, May 5, 2018 between the hours of 9 a.m. and 3 p.m. Registration is open through Thursday, May 10, 2018.

#### **Voter Qualifications**

An individual must:

- Be a U.S. citizen, 18 years of age or older
- Have been a resident of the school district for 30 days preceding the day of the vote

#### **Absentee Ballots**

Absentee ballots are permitted in all school board elections and/or referenda. Absentee ballots may be cast by a qualified voter who is:

- A patient in a hospital or who is unable to vote because of illness or physical disability
- Out of the county of residence on election day because of business, vacation, or other duty

#### **Requesting Absentee Ballots**

Any person seeking an absentee ballot must complete an application obtained from the District Clerk, Kimberly Monzon, one of the schools' secretaries, or downloaded from the district's website, www.klschools.org and return it to the District Clerk by mail or in person.

If the application is returned by mail, it must be received by the District Clerk by Tuesday, May 8, 2018. The mailing address is P.O. Box 387, Katonah, NY 10536. If the application is delivered personally, it must be received by the District Clerk no later than 5 p.m. on Monday, May 14, 2018. The District Office is located at 60 North Salem Road, Cross River, NY 10518.

Once the District Clerk receives the application, an absentee ballot will be mailed to the address specified on the application. Absentee ballots must be received by the District Clerk no later than 5 p.m. on Tuesday, May 15, 2018.


