SUPERINTENDENT'S REPORT

Dr. Frusher updated the Board of Education on the following items:

- Everyone has returned from winter break, SD 194 staff members are well rested, and are energized to continue to move our school district forward for our students, families, and one another, as a team.
- My formal observations of our Principals, Associate Principals, and Assistant Principals are completed. They're working on their artifacts and their self-reflection. Their evaluations will all be completed by March 1, 2020. All PERA state guidelines and timelines are being followed and will be met.
- Our Professional Learning Communities at Work process continues to move forward "Learning by Doing". Our staff members continue to work very hard in our PLC process. We continue to have PLC cycles focusing on student learning, through collaboration, utilizing Common Formative Assessment Data (Benchmark Assessment Data). Our staff continues to put a heavy emphasis on focusing on Essential Standards. Our SD 194 PLC Guiding Coalition, made up of teachers and administrators, met this afternoon. Members from this team will be invited and selected to attend the PLC at Work Institute in August 2020, which will be almost all teachers attending.
- On 1/6/2020, we held our first session of Interest Based Bargaining. Both sides brought their statement of issues (many of these issues were the same), and we categorized them by Non-Economic, Potential Economic, and Economic issues, and prioritized them; working as a team, along with our federal mediator Tim Healy from the Federal Mediation & Conciliation Service. Sub committees (Housekeeping, Finance, and Language) were developed. Future Interest Based Bargaining Dates are 1/22/2020, 2/4/2020, 3/2/2020, 3/23/2020, and 4/9/2020.
- 1/9/2020 was Law Enforcement Appreciation Day. SD 194 greatly appreciates the Steger and South Chicago Heights Police Departments. SD 194 provided each police department with submarine sandwiches, thanking them for their service to our communities.
