FINANCIAL STATEMENT OVERVIEW-INCOME STATEMENT GENERAL FUND – 01

As of October 31, 2017 the school has received in Fund 01 a total of \$1,319,103 of current Fiscal Year State, Federal, and Local revenues which is 28% of its current budgeted amount.

As of October 31, 2017 the school has expended in Fund 01 \$1,161,929 which is 27% of its current budgeted expense.

Urban Academy Charter School ended October 2017 with a current fiscal year to date Fund 01 positive balance (revenues received less expenditures incurred) of \$157,174.

FOOD SERVICE FUND - 02

As of October 31, 2017 the school has received in Fund 02 a total of \$848 of current Fiscal Year State, Federal, and Local revenues which is 0% of its current budgeted amount.

As of October 31, 2017 the school has expended in Fund 02 \$82,232 which is 30% of its current budgeted expense.

Urban Academy Charter School ended October 2017 with a current fiscal year to date Fund 02 deficit balance (revenues received less expenditures incurred) of (\$81,384).

FINANCIAL STATEMENT OVERVIEW-BALANCE SHEET

Urban Academy Charter School had a total cash balance of \$1,302,526 at the end of October 2017 reflected across all funds.

Urban Academy Charter School had a balance of \$10,187 in accounts receivable at October 31, 2017.

There was a balance of \$35,445 in current liabilities for general accounts payable and payroll liabilities at October 31, 2017. A portion of the liability is for payroll withholdings on the last day of the month which are not paid until the first days of the next month, thus they are reflected on the current balance sheet.

Urban Academy Charter School had an overall audited fund balance of \$1,850,738 at June 30, 2017 which includes its investments in fixed assets.

FINANCIAL STATEMENT OVERVIEW-BUDGETING AND OTHER FINANCIAL INFORMATIONThe state is currently paying Urban Academy on 330 ADM for the 2017-2018 school year. The FY18 budget is currently based on 350 ADM.

Revenue activity listed on the Summary Income Statement are reflections of current year actual amounts and do not include calculations for revenue earned during the school year but not yet received. These amounts are calculated at year end as part of the audit preparation process.

Expenditures included in the Summary Income Statement are reported on actual activity and known accounts payable activity. Amounts unpaid but included in the statements will be paid for in the following month. Accounts Payable and Salary Accrual amounts are calculated at year end as part of the audit process.

Information reflected in these statements are based on data provided by school leadership and/or state and federal entities. These Statements are prepared for internal purposes and do not reflect audited data.
