If you had a chance to see our high school's spring production of "Guys and Dolls" or one of the many concerts in our schools, then you've seen some of the great examples of active learning taking place in our district. We know that students learn by doing, by collaborating with peers and teachers, and by cultivating their talents and interests.



An engaging, relevant, and active learning environment

The budget presented here supports the continued forward movement of our schools while staying well within the limits of the NYS Tax Cap. It also recognizes that the environments in which our students learn, the spaces in which they create and collaborate, need our ongoing attention.

In this budget, we propose to modernize the lighting system in our high school's auditorium. It is long overdue for an update and will support active learning for years to come. The proposed budget also includes significant upgrades to our secondary libraries—hubs

for learning in which students make meaning with one another and with evolving resources that now reach across the world.

While roof repairs, at home or at school, are not exciting, they are necessary to protect all that is below them. This budget also supports ongoing, preventative maintenance at all five schools and a project at Meadow Pond Elementary School necessary to protect the school's drinking water.

Public schooling is a community partnership that supports our future. As always, I thank you for partnering with us.

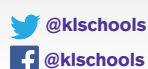

POINTS OF PRIDE FROM THE 2018–19 SCHOOL YEAR



The district received Westchester County's Eco-Award for shifting to 100% green certified electricity.

- Six National Merit Scholarship Finalists.

Athletics

- Fifteen teams received Scholar-Athlete Team Awards for at least 75% of the team having a GPA of 90% or better.
- Over seventy athletes (and counting!) received All League awards and thirty were named All-Section. Four received All County and six were named All-State.
- League Champs: women's basketball, cross country, and soccer; and wrestling.
- Section Champs: women's alpine skiing, cross country, and soccer; football and ice hockey.
- State competition: men's and women's swim & dive, a wrestler, and multiple skiers qualified for States. The ice hockey team is State Regional Champs and qualified for the Frozen Four NYS Hockey Championships. Women's cross country finished 2nd in the NYS Championships.
- Individual accolades include Conference Wrestler of the Year, an Academic All-American Swimmer, and four Players of the Year. Three football players were awarded All-Conference—one was also selected for the All State 1st Team, named Section 1 Player of the Year, and received the Con Edison Scholastic Sports Award.

Visual and Performing Arts

- Elementary students explored art with educators from the Katonah Museum of Art and The Aldrich Museum of Contemporary Art.
- Sixty-six students across the district participated in New York State School Music Association (NYSSMA) Festivals.
- Four students were selected to participate in All-County ensembles and six in Area All-State Festivals.
- More than 300 students brought energy and excitement to the elementary, middle, and high school's theater productions.
- The high school Vocal Jazz Ensemble took first place honors at the Berklee High School Jazz Festival.
- More than 150 students exhibited photographs, paintings, drawings, sculpture and animation in the high school's Rite of Fall and Rite of Spring shows.

- Among our educators' honors: a New York State Master Teacher, a Microsoft Innovative Educator Expert, and four Coach of the Year recipients.

Humanities and More

- Students at all schools had an opportunity to connect with local veterans. Elementary students made cards. The middle school hosted its first Veterans Day Assembly. JJ4Vet's Field of Honor raised awareness and funds.
- Published children's book authors spoke to elementary school students about the writing process.
- A middle school student was named a National Geographic GeoBee New York State Semifinalist
- Mandarin was added to the high school's language offerings.
- Over thirty-five students participated in the high school's Poetry Out Loud competition.
- A senior won the Scholastic Art & Writing Gold Award.

Science, Math, and More

- Elementary students learned about the design process as they created musical instruments, mixed paint, built vehicles, and discovered solutions based on biomimicry.
- The middle school's MATHCOUNTS team placed first at Westchester's MoMathlon competition and will compete at the Tournament of Champions.
- The high school's Science Olympiad team brought home twenty-two medals from the Lower Hudson Valley Regional competition and will compete at States.

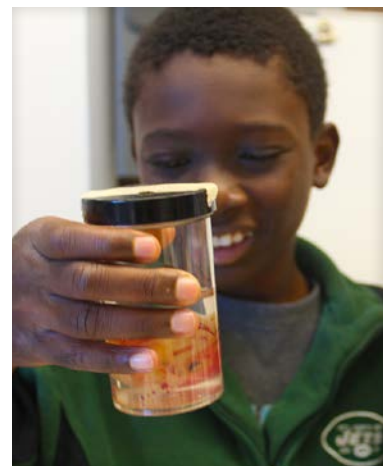


Six teams of high school students pitched behavior-change apps and sustainable solutions at Bedford 2020's Greenlight Competition.

- Nine high school students received awards and recognitions at the Westchester/Putnam Science and Engineering Fair.
- A senior was named a Regeneron Science Talent Search Semi-Finalist.
- Four students will proceed to the Upstate New York Junior Science and Humanities Symposium, two competing for Nationals.
- John Jay's robotics teams advanced to the final rounds of the Hudson Valley FIRST Tech Challenge regional championships at Pace University.

PROPOSITION NO. 1: KLSD BUDGET

The first proposition on the ballot is the Katonah-Lewisboro School District's operating budget for the 2019-20 school year. The proposed budget supports and strengthens the outstanding academic program offered within the Katonah-Lewisboro School District while being fiscally responsible and under the property tax levy cap.



PROPOSITION NO. 2: BUS REPLACEMENT

In addition to the general fund budget proposal, you will have an opportunity to weigh in on a proposition to transfer funds from the 2018-19 general fund to the capital fund to replace four 66-passenger school buses, one wheelchair accessible van, one transportation garage service truck, and one operations and maintenance truck. If approved, there would be no impact on taxes and no additional debt would be incurred.

The passenger vehicles to be replaced have an average of 188,000 miles on their odometers and are between 12 and 14 years old. The cost of each 66-passenger bus is \$116,200. The wheelchair accessible van costs \$72,610. The transportation garage service truck costs \$61,150 and the operations and maintenance truck costs \$49,925.

The replacement of buses and vans on a rotational basis is very important to maintaining safe, dependable transportation. Each of the district's vehicles is inspected by the NYS Department of Transportation twice a year. Our decision to replace the vehicles is based on the inspectors' insights.



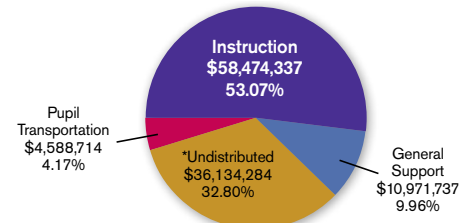
KLSD Transportation Department abides by New York State Environmental Conservation Law which prohibits buses from idling for more than five minutes at a time. Less idling time is good for the environment because it reduces air pollution, noise, and fuel use.

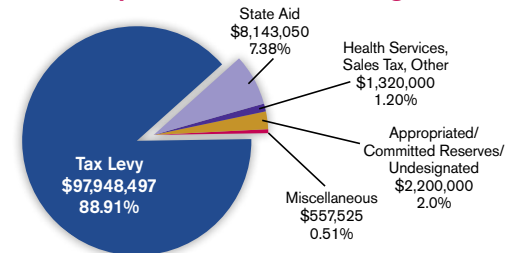
Proposed Expenditure Budget

This would necessitate elimination of the following: \$14,275 - community use of facilities, \$410,506 - instructional, operations and maintenance, and transportation equipment purchases, and \$1,123,429 of other reductions (program expenses, capital expenses, and administrative expenses). VOTER INFORMATION

All voters registered with Westchester County are automatically registered to vote in their school district's budget and school board election. If you are not registered to vote, you may register at any of the schools in the district or at the District Office between the hours of 9 a.m. and 3 p.m. on regular school / business days, as well as at the District Office on Saturday, May 11, 2019 between the hours of 9 a.m. and 3 p.m. Registration is open through Thursday, May 16, 2019.

Voter Qualifications

An individual must:

- Be a U.S. citizen, 18 years of age or older.
- Have been a resident of the school district for 30 days preceding the day of the vote.

Absentee Ballots

Absentee ballots are permitted in all school board elections and/or referenda. Absentee ballots may be cast by a qualified voter who is:

- A patient in a hospital or who is unable to vote because of illness or physical disability.
- Out of the county of residence on election day because of business, vacation, or other duty.

Requesting Absentee Ballots

Any person seeking an absentee ballot must complete an application obtained from the District Clerk, Kimberly Monzon, one of the schools' secretaries, or downloaded from the district's website, www.klschools.org and return it to the District Clerk by mail or in person.

If the application is returned by mail, it must be received by the District Clerk by Tuesday, May 14, 2019. The mailing address is P.O. Box 387, Katonah, NY 10536. If the application is delivered personally, it must be received by the District Clerk no later than 5 p.m. on Monday, May 20, 2019. The District Office is located at 60 North Salem Road, Cross River, NY 10518.

Once the District Clerk receives the application, an absentee ballot will be mailed to the address specified on the application. Absentee ballots must be received by the District Clerk no later than 5 p.m. on Tuesday, May 21, 2019.
