**BE IT RESOLVED,** that it is hereby moved that the Board of Education of the Pocantico Hills Central School District at Sleepy Hollow, New York approve the Summer 2012 contract between Pocantico Hills CSD and the Ardsley UFSD for the provision of Special Educational services at the rate established by the New York State Education Department for one student, which includes basic instruction, psychological consultation, speech therapy, consultation, occupational therapy, physical therapy and adaptive physical education, and an additional amount set by NYSED for a 1:1 or 2:1 aide.
