Finance Chair Report – T. Mattison

- Financial Statement Overview-Income Statement General Fund 01
- As of October 31, 2013 the school has received in Fund 01 a total of \$1,043,446.85 of current Fiscal Year
 - State, Federal, and Local revenues which is 31% of its current budgeted amount.
- As of October 31, 2013 the school has expended in Fund 01 \$1,024,925.95 which is 31% of its budgeted expense.
- Urban Academy ended October 2013 with a current fiscal year to date fund 01 balance (revenues received less expenditures incurred) of \$18,520.90.

Food Service Fund – 02

- As of October 31, 2013 the school has received in Fund 02 a total of \$27,720.99 of current Fiscal Year State, Federal, and Local revenues which is 13% of its current budgeted amount.
- As of October 31, 2013 the school has expended in Fund 02 \$39,119.06 which is 18% of its budgeted expense.
- Urban Academy ended October 2013 with a current fiscal year to date fund 02 balance (revenues received less expenditures incurred) a deficit of \$11,398.07.

`Financial Statement Overview-Balance Sheet

• Urban Academy had a total cash balance of \$944,246 at the end of October 2013 reflected across all funds.

- Urban Academy is expected to receive an additional amount due from State Sources in the amount of
 - \$24,156 calculated at June 30th, 2013 in school fiscal year 2014.
- There was a balance of \$26,229 in current liabilities for general accounts payable and payroll liabilities at
 - October 31, 2013. A large portion of the liability is for payroll withholdings on the last day of the month
 - which are not paid until the first days of the next month, thus they are reflected on the current balance sheet.
- Urban Academy has a current year overall (audited) fund balance of \$1,309,054 at June 30th, 2013 which

includes its investments in fixed assets.

Financial Statement Overview-Supplemental Reports

Also provided within the October Board package prepared for Urban Academy are copies of all payments recorded from all accounts held at Park Bank. All expenditures have been reconciled to the October 2013 bank statements. A journal entry listing has also been provided for board review.

Financial Statement Overview -FY13 Budgeting and Other Financial Information

The State is currently paying Urban Academy based on 267 ADM.

Shift in State Aids

Based on the Minnesota Management and Budget July economic update, and beginning on October 15, 2013, the current year aid payment percentage increased to 90 percent of estimated state aid entitlement. When the current year aid payment percentage moved to 90 percent, charter schools were affected by the implementation of Minnesota Statutes, section 124D.11, Subdivision 9 (a) and will receive 24 payments from July 15th through June 30th, instead of 16 payments between July and February each year. With the implementation of this change Charter schools are not receiving aid for operations during two to three periods between October 2013 and November 2013.

Urban Academy will not need supplemental funding to compensate for this shift in aid due to its careful financial management and established fund balances.
