Congratulations!

The first semester is on the books! We are so pleased to be working with you and your students. We are entering a critical period of time- the Spring Semester. Two very important things will be happening over the course of this semester, one during the week of February 10<sup>th</sup>: Your students will get a picture of their projected graduation date based on their current performance.

We have found that when students regularly update their progress toward graduation, they begin to see the big picture and focus on academic goals. This is critical to their success in achieving a Regents Diploma. Students will see two different pictures, one scenario based on their current performance, and one scenario based on their passing every class and every Regents exam every semester. This helps them see how their efforts impact the length of time it takes to complete their degree here at New Dawn II.

The next important thing happening over this semester is the preparation for internship. Students MUST have earned MORE than 11 credits in order to participate in the program. They will begin training for their Internship placements in the spring, developing a resume and cover letter, as well as practicing critical interview skills.

#### Some reminders:
