WHEREAS, Laumar Roofing Company Inc. was awarded the contract for the Project titled "Roof Replacement at Columbus Elementary and West Lake High School;" and

WHEREAS, Laumar Roofing Company Inc. has substantially breached its contractual obligations to the School District, including but not limited to: (1) its refusal and/or failure to supply suitable materials or equipment to complete the work in a diligent, efficient, timely, workmanlike, skillful and careful manner; (2) its failure to furnish the Owner with assurances satisfactory to it that the contractor has the ability to complete the work in compliance with all of the requirements of the contract documents; and (3) failure to fully comply with the Contract Documents; and

WHEREAS, Laumar Roofing Company Inc. has failed to take the necessary steps to bring itself into compliance with its contractual obligations or to perform its obligations under the contract in a timely manner;

NOW, THEREFORE, BE IT RESOLVED, that in accordance with the provisions of Article 17 of the General Conditions to the contract between the Mount Pleasant Central School District and Laumar Roofing Company Inc., the Board hereby terminates said agreement effective September 27, 2012 without prejudice to any right or remedy which the School District has pursuant to law or a contract.
