Board president David M. C. Stern, vice-president Anish Nanavaty, Board members, Michael Bianchi, David Chao, Jennifer Darger, Jonathan Faust, and Brian Yarrington were present. Superintendent Victoria S. Kniewel and Assistant Superintendent Susan Shirken, District Clerk Rosemary DeVito, Jennifer Allen, Michael Curtin, Eve Feuerstein, Devan Ganeshananthan, Jennifer Johnson, Joseph Schippa, and Edward Stickles also attended. There were seven community members present.

T. CALL TO ORDER

Board president David M. C. Stern called the meeting to order at 7:03 P.M.

At 7:03 P.M. Jennifer Darger made a motion to adjourn the public meeting and to begin Executive Session to discuss special education students, personnel, and legal matters. Brian Yarrington seconded the motion and the motion was approved unanimously.

At 8:17 P.M. Michael Bianchi made a motion to readjourn to public session. Anish Nanavaty seconded the motion and the motion was approved unanimously.

David M. C. Stern recognized Dr. Joseph T. Schippa, Director of Pupil Personnel Services in Edgemont. A "Meet and Greet" took place earlier in the LGI for community, faculty, and staff to welcome and to meet Joe one on one.

Howard Hirsch, School Board Nominating Committee (SBNC) Chairperson, asked that members sign the sign-in-sheet provided at the board meetings when in attendance. Mr. Hirsch welcomed everyone to a new school year.

VI. SUPERINTENDENT'S REPORT

Principals' Reflections on the Opening of School

Jennifer Allen, Devan Ganeshananthan, Edward Kennedy

Victoria Kniewel described the new school year as having "a wonderful start" as students eagerly arrived at school. Victoria commented on the posters, "Focus Forward," that can be seen throughout the campus and said the entire poster was designed in 2015 by an Edgemont High School graduate, Yujin Tsuruo, during Senior Options. All faculty and staff received a copy of this poster that highlights the Edgemont School District Strategic Goals in the areas of Technology, Professional Development, and Local/Global Citizenship. The poster also includes some reflective questions to explore as well.

Victoria reported on district enrollment and said that the enrollment is "relatively flat" with approximately 1,924 students K-12. She then invited the principals to address the board and the community to talk about highlights of the first day of school.

Devan Ganeshananthan said that he welcomed 31 new families to EHS so far and anticipates more to come. He described the incoming students as diverse and eager to start the new school year. He also reported a total of 170 students in seventh grade. Devan thanked the PTSA for their support of the Student Center renovation in the guidance office.

Jennifer Allen spoke on behalf of Greenville School and said Greenville experienced "an energetic first day." Jen talked about the Recycling Program at Greenville and that T-shirts for this initiative were provided by the Edgemont School Foundation. Jen said there was a very successful school-wide assembly with Oscar the Grouch and the Greenville Recycling Rangers. Faculty and Staff welcomed 23 new children and seven new teachers partly due to the expanded new Intensive Communication Achievement Program (ICAP). Jen concluded by saying how excited she is to have everybody back.

Ed Kennedy reported that he welcomed 520 students at Seely Place School. Seely now has 25 class sections and one self-contained class. Ed said the morning began with a school-wide assembly where students pledged a "No Place for Hate" promise promoting anti-bullying and kindness toward others. He described the morning as "very exciting" and "lots of good fun."

Jonathan Faust asked if there were any "unexpected headaches" in any of the schools. Jen Allen reported the air conditioning was not working in some areas and that some of the classrooms were very hot. Ed Kennedy echoed Jen's comments regarding the heat in some of the classrooms.

Brian Yarrington asked Ed and Jen if there is concern regarding enrollment in any grade level that may be cause to add an additional class section. Ed Kennedy responded that the fifth-grade class is large and is comprised of three sections; however, he is comfortable with the current enrollment. Jen Allen said that Greenville's third grade class has 91 students comprising four sections. Ed added that Seely's third grade enrollment is at 68. David M. C. Stern commented that the "jump" refers to the district guidelines.

Summer Curriculum Work Update

Michael Curtin

Victoria Kniewel introduced Mike Curtin to talk about the summer curriculum work update. She said Mike will give the board and the community an idea of the work that was done by teachers this summer under Mike's leadership.

Through PowerPoint, Mike gave an overview on the various summer curriculum projects and highlighted some of the more interesting ones. Mike said he is confident that the work that was done will help to improve the Edgemont experience for students not only during the coming school year but also in the future.

Mike explained that during the spring, teachers are given the opportunity to submit proposals for their projects. The proposals are reviewed by the three building principals and him. This year 16 of the 25 proposals submitted were approved at a cost of approximately \$73,000. He explained that the funding was from the district operating budget and a federal grant. Mike then talked about some of the more "ambitious" projects: Grades 7 – 12 Math Curriculum Alignment; New Social Studies framework; Grade 5 Digital Citizenship curriculum; and Next Generation Science Standards Orientation & curriculum Study.

Mike concluded that the projects are aligned with the district's evolving strategic plan and reflected energy, enthusiasm, creativity, and insight among the teachers who wrote them.

David M. C. Stern thanked Mike for his guidance and leadership in this initiative.

Mike received a round of applause for his presentation.

Victoria Kniewel asked the board to approve Personnel Items A.1., A.2., A.3., A.4., A.5., A.6., A.7., A.8., A.9.; and Walk-in-Items A.10., A.11., and A.12. as a group.
