The Superintendent recommends action on the following matters. Resolved that

1. The resignation of Sara LeBlanc, Special Education Supervisor be accepted effective March 7, 2019.
2. A Maternity Leave of Absence be granted to Julie Dore, Port Chester, New York, as Elementary Teacher at the Middle School, beginning approximately April 23, 2019 through June 4, 2019. Mrs. Dore will use accumulated sick leave during the time her doctor attests to her inability to perform her duties due to pregnancy, delivery and self-care. If needed, the remainder of her Leave of Absence will be a Family Medical Leave without pay; but benefits will continue to a maximum of 12 weeks.
3. A Maternity Leave of Absence be granted to Angela Palombo, Ossining, New York, as Special Education Teacher at Edison School, beginning approximately April 1, 2019 through June 30, 2019. Ms. Palombo will use accumulated sick leave during the time her doctor attests to her inability to perform her duties due to pregnancy, delivery and self-care. If needed, the remainder of her Leave of Absence will be a Family Medical Leave without pay; but benefits will continue to a maximum of 12 weeks.
4. A Maternity Leave of Absence be granted to Sara Stio, Port Chester, New York, as English Teacher at the High School, beginning approximately April 24, 2019 through June 5, 2019. Mrs. Stio will use accumulated sick leave during the time her doctor attests to her inability to perform her duties due to pregnancy, delivery and self-care.
